- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Peritions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Bradfield, Mr J. J. Brown, Mr Burns, Mr Fife, Mr Jarman, Dr Jenkins, Mr L. K. Johnson, Mr L. R. Johnson, Mr Lucock, Mr Martin and Mr Sainsbury—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Bryant, Dr Everingham, Mr Howe, Mr Hurford, Dr Jenkins, Mr Kerin and Mr West—from certain citizens praying for the resignation of Members who have not honoured an election undertaking to retain twice-yearly adjustments of social security pensions in accordance with movements in the consumer price index.
 - Mr Bradfield, Mr Howe, Mr L. R. Johnson and Mr Neil—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Bradfield—from certain citizens praying for the prohibition of oil exploration within the Great Barrier Reef region and that the entire region be declared a Marine Park.
 - Mr Hayden—from certain citizens praying that pensions be adjusted at 6 monthly intervals.
 - Mr Keating—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.
 - Mr J. L. McMahon—from certain citizens praying that major traditional Aboriginal land areas be resumed from the States eventually to become defined Aboriginal community co-operatives.

Petitions received.

- 3 QUESTIONS: Questions without notice were asked.
- 4 PAPER: The following paper was presented, pursuant to statute:
 - Dairy Produce Act—Australian Dairy Corporation—3rd Annual Report and financial statements, together with the Auditor-General's Report, for year 1977-78.
- 5 CUSTOMS AMENDMENT BILL 1979—LEGISLATION COMMITTEE: Mr Sinclair (Leader of the House), by leave, moved—That sessional order (9) relating to the meetings of legislation committees be suspended in relation to the Customs Amendment Bill 1979. Debate ensued.

Question-put and passed.

- 6 SPECIAL ADJOURNMENT: Mr Sinclair (Leader of the House) moved—That the House, at its rising, adjourn until Tuesday, 22 May next, at 2.15 p.m., unless Mr Speaker shall, by telegram or letter addressed to each Member of the House, fix an alternative day or hour of meeting.

- 7 FAMILY LAW ACT—JOINT SELECT COMMITTEE: Mr Speaker informed the House that the Opposition Whip had nominated Dr Blewett to be a member of the Joint Select Committee on the Family Law Act in place of Mr Stewart, deceased.
- 8 EXPENDITURE—STANDING COMMITTEE: Mr Speaker informed the House that the Opposition Whip had nominated Mr Dawkins to be a member of the Standing Committee on Expenditure in place of Mr Stewart, deceased.
- 9 CUSTOMS AMENDMENT BILL 1979—LEGISLATION COMMITTEE: Mr Speaker informed the House that Mr Hurford had been discharged from the legislation committee considering the Customs Amendment Bill 1979 and that Mr Bryant had been nominated in his place.
- 10 GRIEVANCE DEBATE: Pursuant to the provisions of standing order 106, the order of the day having been read—

Question proposed—That grievances be noted.

12 NATIONAL FLAG—EXTENSION OF PREE ISSUE—MINISTERIAL STATEMENT: Mr McLeay (Minister for Administrative Services), by leave, made a ministerial statement informing the House of the Government's decision to extend the free issue of the national flag and cassette recordings of the national anthem and national tune and to make available colour photographs of The Queen.

Mr Scholes and Mr Young, by leave, also made statements with reference to the matter. Mr Bourchier and Mr L. R. Johnson each asked leave to make a statement in connection with the matter.
