THURSDAY, 23 AUGUST 1979

- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITORS: Mr Speaker informed the House that a Parliamentary delegation from the Solomon Islands, led by the Honourable Dr Francis Kikolo, M.P., Minister for Home Affairs, was present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a very warm welcome.
- 3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Aldred, Mr Bourchier, Mr N. A. Brown, Mr Falconer, Mr Hodgman, Mr Jarman, Dr Jenkins, Mr B. O. Jones, Mr Porter, Mr Simon and Mr Yates—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Anthony, Mr Keating and Mr L. R. Johnson—from certain residents of New South Wales praying that the 1980 level of education expenditure to Government schools be restored and increased in real terms.
 - Mr Falconer and Mr Martyr—from certain citizens praying that the National Women's Advisory Council be abolished.
 - Mr N. A. Brown—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Howe—from certain citizens praying that a humane policy be adopted to assist refugees to enter Australia.
 - Mr Howe—from certain citizens praying that the House take steps to create employment opportunities.
 - Mr Howe—from certain members of the Uniting Church of Australia praying that the advertising of alcohol on radio and television be banned and that Federal grants to sporting and cultural bodies be conditional on those bodies not accepting support from manufacturers and retailers of alcohol.
 - Mr Hunt—from certain citizens praying that the Department of Health directive to charge Community Health Centre patients be rescinded.
 - Mr Kerin—from certain citizens praying that pensions be increased twice yearly in line with rises in the consumer price index and that certain other social security benefits be granted.
 - Mr MacKellar—from certain citizens praying that action be taken to admit 2 000 Cambodian refugees immediately, provide financial assistance to the Thai government to establish emergency island camps, and release the family reunion criteria.

Mr Martyr—from certain citizens praying for the prohibition of pornographic material involving children.

Mr Martyr—from certain citizens praying that the National Health Scheme patient contribution rate not be increased.

Mr Shipton—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.

Mr Shipton—from certain citizens praying that the allowable private income level earned by sheltered workshop invalid pensioners be doubled to \$40 per week and then indexed.

Mr Wallis—from certain citizens praying that subsidies to pre-schools be increased.

7 NUCLEAR SAFEGUARDS AGREEMENTS—PAPERS AND MINISTERIAL STATEMENT: Mr Peacock (Minister for Foreign Affairs), by command of His Excellency the Governor-General, presented the following papers:

Nuclear Safeguards Agreements between—

Australia and the United Kingdom of Great Britain and Northern Ireland concerning nuclear transfers between Australia and the United Kingdom, done at London on 24 July 1979, together with an agreed minute and an exchange of letters, dated 24 July 1979.

Australia and the United States of America concerning peaceful uses of nuclear energy, done at Canberra on 5 July 1979, together with an agreed minute—and, by leave, made a ministerial statement relating to the agreements.

Mr Bowen (Deputy Leader of the Opposition), by leave, also made a statement relating to the agreements.

8 DEFENCE EXPENDITURE—MINISTERIAL STATEMENT—PAPER NOTED: Mr Killen (Minister for Defence), by leave, made a ministerial statement informing the House of budgetary measures concerning defence expenditure, and, by command of His Excellency the Governor-General, presented the following paper:

10 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—HOUSING NEEDS: Mr Deputy Speaker informed the House that Mr Uren had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Australian Government to meet the housing needs of low and middle income earners". The proposed discussion having received the necessary support—
Mr Uren addressed the House.

Bill read a first time.
Mr Viner (Minister representing the Attorney-General) moved—That the Bill be now read a second time.
Debate adjourned (Mr Bowen—Deputy Leader of the Opposition), and, by leave, the resumption of the debate made an order of the day for a later hour this day.

12 MESSAGE FROM THE SENATE—TELECOMMUNICATIONS AMENDMENT BILL 1979: Message No. 295, dated 23 August 1979, a.m., from the Senate was reported transmitting for the concurrence of the House a Bill for "*An Act to amend the 'Telecommunications Act 1975'*".
