- 2 ABSENCE OF MR SPEAKER: The Clerk having informed the House that Mr Speaker (the Right Honourable Sir Billy Snedden) was absent, the Chairman of Committees (Mr Millar) took the Chair as Acting Speaker, and read Prayers.
- 3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Baume, Mr J. J. Brown, Dr Klugman, Sir William McMahon, Mr Morris, Mr Ruddock and Mr West—from certain residents of New South Wales praying that the 1980 level of education expenditure to Government schools be restored and increased in real terms.
 - Mr Jarman and Sir William McMahon—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familar weights and measures be restored.
 - Mr Morris and Mr Shipton—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Baume—from certain citizens praying that the proposal to increase the marine radio licence fee be reconsidered.
 - Mr Braithwaite—from certain citizens praying that the proposal to increase the marine radio licence fee be reconsidered and that the regulation allowing the use of CB radio in marine situations be rescinded.
 - Mr J. J. Brown—from certain citizens praying that action be taken to dismiss the present members of the Broadcasting Tribunal and replace them with Janet Strickland and representatives of other broadcasting and television bodies.
 - Dr Edwards—from certain citizens praying for the establishment of a fund whereby loans can be made to means tested pensioners for the necessary maintenance of their homes.

 - Sir William McMahon—from certain electors of New South Wales praying that the Commonwealth Employees (Employment Provisions) Act 1977 be repealed.
 - Mr Porter—from certain citizens praying that subsidies to pre-schools be increased to provide adequate pre-school services in South Australia.
 - Mr Thomson—from certain citizens praying that federal funding to State schools be restored to 1974–75 levels, that the independence of the Schools Commission be maintained and that tied grants be made to Queensland to ensure achievement of national standards.

Mr Wilson-from certain citizens praying that the decision by Australia Post not to issue a commemorative stamp to mark the 50th anniversary of Apex Clubs be reconsidered.

- 20 CONSTITUTIONAL AND LEGAL AFFAIRS—SENATE STANDING COMMITTEE—REPORT ON PRIORITY OF CROWN DEBTS—GOVERNMENT RESPONSE—MINISTERIAL STATEMENT: Mr Fife (Minister for Business and Consumer Affairs), by leave, made a ministerial statement informing the House of the Government's response to the report of the Senate Standing Committee on Constitutional and Legal Affairs on priority of Crown debts.
 - Mr Bowen (Deputy Leader of the Opposition), by leave, also made a statement in connection with the matter.
- 21 APPROPRIATION BILL (No. 1) 1979-80—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Mr Willis moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the second reading, this House condemns the Fraser Government for presenting a budget which—

i.

- (1) reduces the real living standards of Australian families;
- (2) will increase unemployment to the highest level in the nation's history;
- (3) facilitates and stimulates the recent fresh outbreak of inflation;
- (4) ensures that economic growth will be well below the nation's productive capacity;
- (5) fails to introduce an effective job creation program, particularly for the young;
- (6) savagely reduces the allocation of funds for job training and re-training program;
- (7) will be responsible for the highest level of tax and total revenue collections in the nation's history;
- (8) forces State and local governments either to reduce their services or increase their charges, and
- (9) intensifies the lack of credibility of the Prime Minister and his government and adds to their long list of broken promises".

Debate continued.

- Debate adjourned (Mr Graham), and the resumption of the debate made an order of the day for a later hour this day.
- 22 PRIVILEGE—STATEMENT BY MR ACTING SPEAKER: Mr Acting Speaker referred to the matter raised earlier this day by Mr Morris as a matter of privilege concerning the alleged threat to Mr Morris in the House by another honourable Member and stated that, as Mr Morris had indicated that he did not wish to pursue the matter and Mr Sinclair (Leader of the House) had explained that he had misunderstood the intention of Mr Morris in approaching the Chair at the time, it would be idle of the House to pursue the matter of privilege.

Mr L. R. Johnson, Mr Sinclair and Mr Morris addressed the House on the matter.
