- "(17) Upon the completion of consideration of the reports of Estimates Committees, the question shall be proposed forthwith—"That the remainder of the Bill be agreed to'.", and
- (2) That the proposed expenditures for the departments and services contained in Schedule 2 to the Appropriation Bill (No. 1) 1980-81 be referred, as indicated, to Estimates Committees A, B, C and D for examination and report by close of business, 9 September 1980:
