- 1 The House met at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER PREMIER OF SOUTH AUSTRALIA (THE HONOURABLE SIR THOMAS PLAYFORD): Mr Speaker informed the House of the death, on 16 June 1981, of the Honourable Sir Thomas Playford, G.C.M.G., a former Premier of South Australia.
 - As a mark of respect to the memory of the deceased all Members present stood, in silence.

- 16 MESSAGE FROM THE GOVERNOR-GENERAL, PROPOSED EXPENDITURE, APPRO-PRIATION FOR PAYMENT OF INCREASES IN SALARIES AND WAGES, AND APPROPRIATION FOR LOAN CONSOLIDATION AND INVESTMENT RESERVE, FOR YEAR 1981-82—APPROPRIATION BILL (NO. 1) 1981-82—BUDGET SPEECH: Message No. 79, dated 17 August 1981, from His Excellency the Governor-General was announced:
 - (a) transmitting to the House of Representatives particulars of proposed expenditure from the Consolidated Revenue Fund for the service of the year ending on 30 June 1982, and recommending an appropriation of the Consolidated Revenue Fund accordingly; and

- (c) further recommending to the House of Representatives an appropriation of the Consolidated Revenue Fund in respect of the year ending on 30 June 1982, for the purposes of the Loan Consolidation and Investment Reserve established by the Loan Consolidation and Investment Reserve Act 1955, of such sums as the Minister for Finance from time to time determines.
