## TUESDAY, 8 SEPTEMBER 1981

- 1 The House met, at 1.45 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (THE HONOURABLE DAME ENID LYONS): Mr Anthony (Acting Prime Minister) referred to the death of the Honourable Dame Enid Lyons, and moved—That this House expresses its deep regret at the death, on 2 September 1981, of the Honourable Dame Enid Muriel Lyons, A.D., G.B.E., a Member of this House for the Division of Darwin from 1943 to 1951 and Vice-President of the Executive Council from 1949 to 1951, and widow of the former Prime Minister, the Rt Hon. J. A. Lyons, places on record its appreciation of her long and meritorious public service and tenders its profound sympathy to her family in their bereavement.
  - And Mr Hayden (Leader of the Opposition) having seconded the motion, and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

    Ouestion—passed.
- 3 DISTINGUISHED VISITORS: Mr Speaker informed the House that members of the Nigerian Senate's Committee on Public Works, led by Senator Awyanwu, Chairman of the Committee, were present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a very warm welcome.
- 4 PRIVILEGE: Mr Ruddock raised a matter of privilege based on a printed reference and an article by Mr L. Oakes relating to Members of the Commonwealth Parliament appearing on pages 1 and 9, respectively, of the *Daily Mirror* of 2 September 1981. Mr Ruddock produced a copy of the *Daily Mirror* containing the material and gave the name of the printer and publisher of that newspaper.
  - Mr Speaker stated that he had formed the opinion that there was a *prima facie* breach of privilege and stated that he would exercise his discretion not to give the matter precedence immediately but would allow Mr Ruddock time to consider the form of motion he might wish to move.
- 5 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

  - Dr Blewett, Mr Howe, Mr Mountford and Mr Scholes—from certain citizens praying that steps be taken to re-introduce a system of health care based on ability to pay and that access to health care be based on medical need.

- Mr Cunningham, Mr Fisher and Mr Nixon—from certain citizens praying that steps be taken to prevent the Australian Postal Commission implementing any plan which will downgrade postal and mail services.
- Mr Killen—from certain residents of the Electoral Division of Moreton in the same terms as the last preceding petitions.
- Mr Bourchier, Mr Fisher and Mr Jarman—from certain citizens praying that ex-servicewomen who volunteered for service in the 1939-45 war but were not sent to war zones be considered eligible for defence service home loans.
- Mr Cunningham, Mr Falconer and Mr Shipton—from certain citizens praying that immediate and positive action be taken to avert further poverty and suffering in the community by raising the level of all pensions and benefits to the poverty line and by reconsidering the recent Government decisions taken in relation to the health system.
- Mrs Darling, Dr Everingham and Mr Mountford—from certain citizens praying that any proposal to sell Trans Australia Airlines be rejected.
- Dr Everingham, Mr Hodges and Mr McVeigh—from certain members of Parents and Citizens Associations praying that the Schools Commission and Curriculum Development Centre be retained in their original forms and certain funding proposals and schools improvement programs be retained.
- Mr Cadman and Mr Mountford—from certain citizens praying that funds not be allocated for the development of roads or dams in South-West Tasmania but be provided instead for the preservation of the area.

- Dr Blewett—from certain residents of Salisbury and Elizabeth, S.A., praying that interest rate agreements be reduced annually with a maximum interest percentage ceiling on investors' capital and a scale of interest charges for loans.
- Mr J. J. Brown—from certain citizens praying that women's refuges, health centres and rape crisis centres be funded under special purpose grants administered federally under one Department and certain other actions be taken to ensure the continuing effectiveness of women's services.

- Mr J. J. Brown—from certain citizens praying that taxpayers' money not be used for abortions, subsidies for abortion referral centres be eliminated and Australia's Human Rights Charter include rights for the unborn.

Brown—from certain citizens praying that the decision to pass the responsibility of funding of women's and children's refuges and health and crisis centres to the States be reversed and certain other actions be taken to consolidate the existing services and develop new initiatives for women and children in the community.
- Mr R. J. Brown—from certain citizens praying that an adequate telephone service be provided for residents of the Mulbring/Mount Vincent area of the Hunter Valley, N.S.W.
- Mr Carlton—from certain citizens praying that all photocopying and video-recording used exclusively for education purposes be exempted from the provisions of the Copyright Act.
- Mrs Darling—from certain citizens praying that the proposal to transfer funding of women's refuges to the States not be proceeded with and Federal funding levels for women's refuges be increased.
- Mrs Darling—from certain citizens praying that no approval be given to the application of Trans Australia Airlines or any other airline for a relaxation or withdrawal of the curfew at Eagle Farm Airport, Qld.

- Mr Dobie—from certain citizens praying that certain recommendations of the Law Reform Commission discussion paper on Privacy and Personal Information be rejected and some other means be found to protect children from the excessive abuse of some parents.
- Mr Duffy—from certain citizens praying that immediate and positive action be taken to avert any further effects of increases in interest rates on home mortgage loans.
- Dr Everingham—from certain citizens praying that service pensions be extended to all merchant seamen who served in theatres of war.
- Mr Fry—from certain citizens praying that realistic funding levels be introduced to maintain existing services offered by women's refuges and certain other actions be taken to ensure the continuing effectiveness of the women's refuge program.
- Mr Goodluck—from certain citizens praying that the Bellerive Post Office, Tas., be retained.
- Mr Groom—from certain citizens praying that public debate be promoted and a referendum be held to decide upon a new Constitution for Australia.
- Mr Hodgman—from certain citizens praying that the value of family allowances be restored and then indexed and the spouse rebate be increased to \$1,342 per year.

10 MEAT SUBSTITUTION—MINISTERIAL STATEMENT: Mr Nixon (Minister for Primary Industry), by leave, made a ministerial statement relating to the substitution of horse and kangaroo meat for boneless beef exports and the measures being taken by the Government in relation to the matter.

Mr Hayden (Leader of the Opposition), by leave, also made a statement with reference to the matter.

11 SUSPENSION OF STANDING ORDERS—MOTION OF CENSURE OF MINISTER FOR PRIMARY INDUSTRY: Mr Hayden (Leader of the Opposition) moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving a motion of censure of the Minister for Primary Industry. Question—put and passed, with the concurrence of an absolute majority.

12 MINISTER FOR PRIMARY INDUSTRY—MOTION OF CENSURE: Mr Hayden (Leader of the Opposition) moved—That this House, whilst endorsing the need for a Royal Commission of Inquiry with the broadest terms of reference into the meat processing, distribution and export industries, censures the Minister for Primary Industry for the extraordinarily incompetent way he has handled this matter, including his confession that he was aware of aspects of this scandal 12 months ago but concealed the facts from the public, and declares that he should be discharged from his office as a Minister of the Crown.
