- 1 The House met, at 1.45 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Charles, Mrs Child, Mr Duffy, Mr Mildren, Mr Milton, Dr Theophanous and Mr Willis—from certain citizens praying that insulin syringes for diabetics be made available on the National Health Scheme and insulin prescriptions revert to 10 bottles.
 - Mr Adermann, Mr Drummond, Mr Hall, Mr Hurford and Mr McLean—from certain citizens praying that the proposed sales tax on books, magazines and newspapers be withdrawn from the Budget proposals.
 - Mr Bowen and Mr Hurford—from certain residents of New South Wales and South Australia, respectively, praying that the offer of Darwin or any other location as a base or depot for American B-52 bombers be withdrawn and any request by the United States Government for the use of bases in Australia be rejected.
 - Mr Cross and Dr Everingham—from certain members of Parents and Citizens Associations praying that the Schools Commission and Curriculum Development Centre be retained in their original forms and certain funding proposals and schools improvement programs be retained.
 - Mr Cunningham and Mr Mildren—from certain residents of the Electoral Division of Ballarat praying that immediate attention be given to an already seriously depressed housing industry.
 - Mr Free and Mr Mountford—from certain citizens praying that disabled people be recognised as citizens who should have equal rights and that certain actions be taken to enable adequate planning of services needed by partially or totally disabled people to be undertaken.
 - Mr Kent and Mr Milton—from certain citizens praying that the rights of Australian workers in the automotive industry be protected by rejecting any proposal to reduce the level of tariff protection for the industry.
 - Dr Theophanous—from certain electors of the Electoral Division of Burke in the same terms as the last preceding petition.
 - Mr Adermann—from certain residents of Mount Mee, Qld, praying that immediate attention be given to the installation of a new telephone exchange at Mount Mee.
 - Mr Beazley—from certain citizens praying that Australia make an immediate and substantial offer of food aid to the Polish Government.
 - Mr I. M. D. Cameron—from certain citizens praying that the imperial system of weights and measures be restored.
 - Mr I. M. D. Cameron—from certain citizens praying that the cost of installation of automatic telephone services be the same in country areas as in the cities.

Mr Charles—from certain residents of Victoria praying that musicians dismissed from the A.B.C. Melbourne Showband be re-instated and that funds be made available to enable the band to continue.

Mrs Child—from certain citizens praying that the proposed changes to assistance to the passenger motor vehicle and components industries after 1984 as recommended by the Industries Assistance Commission not be given effect.

Mr Cross—from certain citizens praying that the Government's sales tax legislation be withdrawn or repealed.

Mr Cunningham—from certain citizens praying that steps be taken to prevent the Australian Postal Commission implementing any plan which will downgrade postal and mail services.

Mr Burr and Mr Free—from certain residents of the Electoral Divisions of Wilmot and Macquarie, respectively, in similar terms to the last preceding petition.

Mr Dawkins—from certain citizens praying that the Commonwealth's constitutional and legislative powers be used to grant full land rights and self-management to the Aboriginal people of Queensland.

Mr Drummond—from certain citizens praying that sufficient funds be provided to State education systems to ensure the maintenance of the current high quality of education.

Mr Fisher—from certain citizens praying that the Senate's requested amendments to the Sales Tax Bills be supported.

Mr Groom—from certain residents of north-west and west coast municipalities of Tasmania praying that funds be provided to upgrade Wynyard Airport, Tas., to the standard required for it to accommodate medium size jet aircraft.

Mr Hodgman—from certain citizens praying that steps be taken to prevent the closing of Aspect House for handicapped children, New Town, Tas.

Mr Hodgman—from certain students and staff of the University of Tasmania praying that tuition fees for second and higher degrees not be introduced and that tuition fees not be charged at Australian tertiary education institutions.

12 INCOME TAX ASSESSMENT AMENDMENT BILL (NO. 2) 1981: Mr Howard (Treasurer) presented a Bill for an Act to amend the law relating to income tax. Bill read a first time.

Debate resumed by Dr Blewett who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give this Bill a second reading, the House is of the opinion that it should be re-drafted to provide for—

- (1) the removal of the discrimination against tenants in government housing;
- (2) the removal of the discrimination against the adult unemployed without dependants:
- (3) an increase in the unemployment benefit for the under 18 unemployed;
- (4) the inclusion of the first and second children in the provision of increased family allowances in line with those for third and later children;
- (5) the removal of the provision discriminating against the spouses of union members affected by industrial disputes, and
- (6) the removal of discrimination against the spouses of unemployed persons who fail the work test".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Debate resumed by Dr Blewett who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give this Bill a second reading, the House is of the opinion that it should be re-drafted to—

- (1) remove the discrimination in the provision of supplementary assistance against those in government housing;
- (2) provide repatriation benefits for those who served in peacekeeping forces before 1 November 1981, and
- (3) provide eligibility for service pensions for all Allied ex-merchant mariners as is provided for Allied ex-servicemen".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

15 SPEECHES IN PARLIAMENT—REPRINTS FOR MEMBERS: Dr Klugman raised with Mr Speaker the matter of the form recently attached to the typescript of Members' speeches made in the House which provided for an application for printed copies of speeches and also contained a form of indemnification, to be signed by Members, against all actions, proceedings, claims or demands made against the Principal Parliamentary Reporter and his staff and the Commonwealth Government Printer by reason of any defamatory matter contained in the reprints of speeches.

Mr Speaker explained the purpose of the new form.
