5 STANDING ORDERS COMMITTEE—REFERENCE OF MATTER: Mr Hayden (Leader of the Opposition), by leave, moved—That the following matter be referred to the Standing Orders Committee for examination, report and recommendation:

The standing orders and practices which govern the conduct of Question Time,

taking particular account of:

(1) the definition of relevancy in answers to questions and the setting out of criteria to define relevancy in accordance with legal definition;

(2) length of answers to be subject to a time limit;

(3) the need for clearer definition in the standing orders about the practice in relation to supplementary questions;

(4) Senators who are Ministers to attend the House to answer questions;

(5) the appropriateness of setting down specified sitting days as days on which questions will be directed to Ministers about particular Departments, and

(6) Question Time to be a minimum of 45 minutes.

Debate ensued.

Question—put and passed.

6 SUSPENSION OF STANDING ORDERS MOVED; Mr Sinclair (Leader of the House) moved—That so much of the standing orders be suspended as would prevent notice No. 19, general business, being called on forthwith.

Debate ensued.

Withdrawal of notice: Mr Uren having withdrawn notice No. 19, general business, standing in his name, by notifying the Clerk in writing—

Speaker's ruling: Mr Speaker ruled that, as a consequence of the withdrawal of the notice, the motion for the suspension of the standing orders could not be proceeded with.

7 SUSPENSION OF STANDING ORDERS MOVED: Mr Sinclair (Leader of the House) moved—That so much of the standing orders be suspended as would prevent notice No. 54, general business, being called on forthwith.

Mr Bowen (Deputy Leader of the Opposition) moved, as an amendment—That all words after "suspended" be omitted with a view to substituting the following words: "as would prevent the Minister for Foreign Affairs making a statement on Poland".

Debate continued.

Motion and amendment withdrawn, by leave.

8 UNEMPLOYMENT—PROPOSED JOINT COMMITTEE: Mr. Hawke, pursuant to notice, moved—That, in light of the Government view contained in the 1980-81 Budget papers that there will be no improvement this financial year in the already disastrously high level of unemployment and the consistent glossing over of this fact by the Minister for Employment and Youth Affairs, in the opinion of this House, and as a matter of urgency, a joint committee should be established to inquire into and report on unemployment in Australia, with special reference to—

(1) the extent of unemployment and the degree to which it has become a long term

problem;

(2) the degree to which unemployment bears particularly upon certain industries, regions and sectors of the workforce;

(3) the social implications of prolonged large-scale unemployment;

- (4) the applicability to Australia of innovative employment creating schemes operating in other comparable countries;
- (5) the extent to which unemployment could be reduced by implementing and expanding manpower programs;

(6) other means by which unemployment could be reduced, and

(7) the extent and nature of possible conflict between the objective of reducing unemployment and other policy objectives.

It being 2 hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with standing order 109.

Ordered—That the time for the discussion of notices be extended until 12.15 p.m. Debate continued.

The time allotted for precedence to general business having expired, the debate was interrupted.

Suspension of standing orders—Extended time for debate: Mr N. A. Brown (Minister for Employment and Youth Affairs), by leave moved—That so much of the standing orders be suspended as would prevent the consideration of notice No. 1, general business, being continued until 12.35 p.m.

Question—put and passed.

Debate continued.

The extended time allotted for the consideration of notice No. 1, general business, having expired, the debate was interrupted, Mr N. A. Brown was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.
