- 1 The House met, at 1.45 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 MINISTERIAL CHANGES AND ARRANGEMENTS: Mr Fraser (Prime Minister) informed the House that Mr MacKellar and Mr Moore had this day resigned as Minister for Health and Minister for Business and Consumer Affairs, respectively. In their stead Senator Baume (Minister for Aboriginal Affairs) had been appointed also Minister for Health and would be represented as Minister for Health in this House by Mr Fife (Minister for Education), and Mr N. A. Brown (Minister for Employment and Youth Affairs) had been appointed also Minister for Business and Consumer Affairs.
 - Mr Fraser also informed the House that, during the respective absences abroad of Mr Anthony (Minister for Trade and Resources) and Mr Hunt (Minister for Transport), Mr Sinclair (Minister for Communications) was acting as Minister for Trade and Resources and Mr Fife was acting as Minister for Transport and was representing the Minister for Social Security in this House.
- 3 IMPORTATION OF COLOUR TELEVISION SET BY HON. M. J. R. MACKELLAR— PAPERS—MOTION TO TAKE NOTE OF PAPERS: Mr Sinclair (Leader of the House), by command of His Excellency the Governor-General, presented the following papers: Importation of colour television set by the Hon. M. J. R. MacKellar, M.P.—

 - (c) what actions were taken by the head of the Department in respect of all matters relating to the former Minister for Health and whether these actions were taken with the knowledge and approval of the Government;
 - (d) more generally, whether the Bureau is effective in performing its functions and the steps that need to be taken to ensure that it is an effective organisation and carries out its obligations under the Customs Act, and

(e) whether any other Minister was aware or should reasonably have been aware of these matters and failed to take appropriate action".
