- 6 RESOURCE DEVELOPMENT AND REGIONAL PLANNING: Mr Uren, pursuant to notice, moved—That this House—
 - (1) recognises that rapid and uncontrolled export oriented resource development is creating major regional dislocations throughout Australia and in particular (a) is contributing to the economic decline of regions traditionally dependent on diverse manufacturing industries and (b) has led to a severe imbalance in the development of growing regions whereby public funds are channelled into the provision of physical infrastructure for projects of large corporations while community needs are neglected, and
 - (2) calls on the Government to (a) develop and implement policies for balanced development which take into account the different needs of each of Australia's regions, (b) support regional authorities and assist them to create employment and enter into partnership arrangements with private enterprise to attract new economic activity to their regions and (c) promote planning of public investments and co-ordination of government services on a regional basis through the co-operation of Federal, State and local government.

Mr Mildren seconding the motion—

On the motion of Mr N. A. Brown (Minister for Business and Consumer Affairs), the Bill was read a third time.
