## TUESDAY, 12 OCTOBER 1982

- 1 The House met, at 1.45 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 MINISTERIAL CHANGE AND ARRANGEMENTS: Mr Fraser (Prime Minister) informed the House that, following the resignation yesterday of Sir Phillip Lynch as Minister for Industry and Commerce, Mr Peacock had been appointed Minister for Industry and Commerce.
  - Mr Fraser also informed the House that, during the absence of Mr Street (Minister for Foreign Affairs), Mr Sinclair (Minister for Defence) was acting as Minister for Foreign Affairs.
- 3 PAPER: The following paper was presented, by command of His Excellency the Governor-General:
  - Copy of letter from Mr W. J. O'Reilly, Commissioner of Taxation, to Mr J. B. Reid, dated 24 September 1982, concerning alleged unsatisfied tax liabilities.
- 4 SUSPENSION OF STANDING AND SESSIONAL ORDERS—GENERAL BUSINESS NOTICE: Mr Fraser (Prime Minister) moved—That so much of the standing and sessional orders be suspended as would prevent notice No. 1, general business, given for Tuesday, 12 October 1982, by the Leader of the Opposition, being called on forthwith. Question—put and passed, with the concurrence of an absolute majority.
- 5 COMMITTEE OF REVIEW OF COMMONWEALTH ADMINISTRATION—APPOINTMENT OF MR J. B. REID: Mr Hayden (Leader of the Opposition), pursuant to notice, moved—That this House—
  - (1) deplores the Prime Minister's personal choice of Mr J. B. Reid as a member of the Committee of Review of Commonwealth Administration because the said Mr Reid was a director of 4 separate companies which were sold on 28 June 1977 to 6 directors who are identifiably part of the Brian J. Maher Group shown by the McCabe Lafranchi report as being responsible for massive tax evasion practices, the Maher Group directors in question being John Patrick Donnelly, Terence John Reilly, Al Gottersen, Graham Goldberg, Lee Gabriel Hurley and Geoffrey Delco;
  - (2) condemns the preference of the Government for people identified as being engaged in tax avoidance and evasion to represent it on public instrumentalities, boards and on committees of inquiry, and
  - (3) calls on the Prime Minister to have Mr Reid stand down immediately from the Committee of Review of Commonwealth Administration, the Board of Qantas Airways Limited and the Board of the Australian Bi-Centennial Authority, to which he was appointed by this Government, until these matters are fully investigated.
