Ordered—That the amendments be taken into consideration, in committee of the whole House, forthwith.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

No. 1—Page 7, clause 11, sub-clause (3), lines 12 to 15, leave out the sub-clause, insert the following sub-clause:

“(3) The functions of the Australian Broadcasting Corporation Advisory Council are—

- (a) either on its own initiative or at the request of the Board, to furnish advice to the Board on matters relating to broadcasting programs and television programs of the Corporation; and
- (b) either on its own initiative or at the request of the Managing Director, to make recommendations to the Managing Director in accordance with sub-section 82 (3).”.

No. 2—Page 7, clause 11, sub-clause (4), lines 16 to 21, leave out the sub-clause, insert the following sub-clause:

“(4) The functions of an Advisory Council established under sub-section (2) are—

- (a) in the case of an Advisory Council established in relation to a State, Territory or region—either on its own initiative or at the request of the Australian Broadcasting Corporation Advisory Council, to furnish advice to the Australian Broadcasting Corporation Advisory Council on matters relating to broadcasting programs and television programs of the Corporation in that State, Territory or region, as the case may be; and
- (b) in the case of an Advisory Council established in relation to a State or Territory—either on its own initiative or at the request of the Managing Director, to make recommendations to the Managing Director with respect to the appointment of Community Affairs Officers in relation to that State or Territory.”.

No. 3—Page 16, clause 27, before sub-clause (1), insert the following new sub-clause:

“(1A) The Corporation shall develop and maintain an independent service for the broadcasting and televising of news and information by the Corporation pursuant to this section.”.

No. 4—Page 52, clause 82, sub-clause (3), lines 1 to 8, leave out the sub-clause, insert the following sub-clause:

“(3) The Managing Director shall—

- (a) on the recommendation of—
 - (i) the Advisory Council established in relation to the State or Territory concerned; or
 - (ii) if no such Advisory Council has been established—the Australian Broadcasting Corporation Advisory Council, appoint, in each State, in the Northern Territory and in the Australian Capital Territory, a person or persons, to be known as Community Affairs Officers, to consider complaints mentioned in sub-section (1); and
- (b) on the recommendation of the Australian Broadcasting Corporation Advisory Council, appoint an officer of the Corporation, to be known as the Principal Community Affairs Officer, whose duties will consist of or include the co-ordination of the activities of the Community Affairs Officers.”.

On the motion of Mr Duffy (Minister for Communications), the amendments were agreed to, after debate.

Resolution to be reported.

30 TAXATION (UNPAID COMPANY TAX) ASSESSMENT AMENDMENT BILL 1983: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

Mr Dawkins, by leave, moved the following amendments together:

Clause 10, page 13, line 23, after “will be paid” insert “or would, but for the operation of section 265 of the Assessment Act, be paid”.

Clause 19, page 22, lines 4 and 5, omit the clause, substitute the following clauses:

Arrangements for payment of company tax

“19. Section 20 of the Principal Act is amended—

- (a) by inserting in paragraphs (1) (a) and (c) ‘ordinary’ before ‘company tax’;
- (b) by omitting from sub-section (1) ‘and undistributed profits tax’ (wherever occurring); and
- (c) by inserting in sub-section (2) ‘ordinary’ before ‘company tax’ (wherever occurring).

Instalment arrangements in relation to payment of company tax

“19A. Section 21 of the Principal Act is amended—

- (a) by inserting in paragraphs (1) (a), (c), (d), (f), (g) and (h) ‘ordinary’ before ‘company tax’;
- (b) by omitting from sub-section (1) ‘and undistributed profits tax’ (wherever occurring); and
- (c) by omitting from sub-section (1) ‘or such longer period as the Commissioner, in special circumstances, determines’.

“19B. After section 21 of the Principal Act the following section is inserted:

Instalment arrangements in relation to payment of income tax or dividend recoupment tax

“21A. (1) Where—

- (a) an assessment has been made under which income tax is payable by a person;
- (b) the whole or a part of the income tax payable under the assessment (which whole or part is in this sub-section referred to as the “relevant tax”) is attributable to the inclusion of an amount in the assessable income of the person by virtue of the operation of section 6C or 6D;
- (c) no objection has been lodged against the assessment on a ground relating to the inclusion of that amount in the assessable income of the person; and
- (d) the person has, within 30 days after service of the notice of the assessment, made an application in writing to the Commissioner for an arrangement under this section in relation to the payment of the relevant tax by instalments,

the Commissioner may enter into an arrangement with the person in relation to the payment by instalments, over a period of 12 months commencing on the date of service of the notice of assessment, of the relevant tax and, where such an arrangement is entered into, all payments made in accordance with the arrangement shall, for the purposes of the Assessment Act, be deemed to have been made at the time when the first payment was made in accordance with the arrangement.

'(2) Where—

- (a) an assessment has been made under which dividend recoupment tax is payable by a person;
- (b) no objection has been lodged against the assessment; and
- (c) the person has, within 30 days after service of the notice of the assessment, made an application in writing to the Commissioner for an arrangement under this section in relation to the payment of the dividend recoupment tax by instalments,

the Commissioner may enter into an arrangement with the person in relation to the payment by instalments, over a period of 12 months commencing on the date of service of the notice of assessment, of the dividend recoupment tax and, where such an arrangement is entered into, all payments made in accordance with the arrangement shall, for the purposes of this Act, be deemed to have been made at the time when the first payment was made in accordance with the arrangement.

'(3) Where, after an arrangement referred to in sub-section (1) or (2) is entered into, an objection is lodged against the assessment referred to in paragraph (1) (a) on a ground referred to in paragraph (1) (c) or an objection is lodged against the assessment referred to in paragraph (2) (a), as the case may be, the arrangement shall be deemed never to have been entered into.' "

Debate continued.
