- The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Honourable Dr H. A. Jenkins) took the Chair, and read Prayers.
- 2 **PETITIONS:** The Acting Clerk announced that the following Members had each lodged petitions for presentation, viz.:

 - Mr O'Neil, Mr Porter and Mr Scott—from certain residents of South Australia praying that legislation be enacted to ban the advertising of alcohol from commercial television and radio.
 - Mr Burr and Mr Hodgman—from certain citizens praying that the Sex Discrimination Bill be amended to prevent inconsistencies with the principles of justice and equality and that a conscience vote on the Bill be permitted to all Members of Parliament.
 - Mr Blanchard and Mr Free—from certain citizens praying that the ban on the export of kangaroo products be re-applied.
 - Mrs Mayer and Mr Steedman—from certain citizens praying that the Omega base in Victoria be closed.
 - Mr Hand—from certain citizens praying that pensioners be absolved from increases in telephone charges and be charged for calls only.
 - Mr Ruddock—from certain citizens praying that the Government refrain from ratifying the Convention on the Elimination of All Forms of Discrimination Against Women.

- 4 SOCIAL SECURITY LEGISLATION AMENDMENT BILL 1983: Mr Holding (Minister for Aboriginal Affairs), for Mr Dawkins (Minister for Finance), pursuant to notice, presented a Bill for an Act relating to social security and related matters. Bill read a first time.
 - Mr Holding moved-That the Bill be now read a second time.

Debate adjourned (Mr Carlton), and the resumption of the debate made an order of the day for the next sitting.

- 5 REPATRIATION LEGISLATION AMENDMENT BILL 1983: Mr Holding (Minister representing the Minister for Veterans' Affairs), for Mr Dawkins (Minister for Finance), pursuant to notice, presented a Bill for an Act relating to repatriation and related matters.
 - Bill read a first time.

Mr Holding moved—That the Bill be now read a second time.

Debate adjourned (Mr Ruddock), and the resumption of the debate made an order of the day for the next sitting.

- 9 LOCAL GOVERNMENT PERSONAL INCOME TAX SHARING—LOCAL GOVERNMENT GRANTS COMMISSIONS RECOMMENDATIONS—MOTION TO TAKE NOTE OF PAPER: Mr Uren (Minister for Territories and Local Government) presented the following paper:
 - Local Government (Personal Income Tax Sharing) Act—Recommendations of Local Government Grants Commissions on the distribution of local government's share of personal income tax collection for 1983-84 for—

New South Wales. Queensland. South Australia. Tasmania. Victoria. Western Australia.

Mr Dawkins (Minister for Finance) moved—That the House take note of the paper. Debate adjourned (Mr Sinclair—Deputy Leader of the National Party of Australia), and the resumption of the debate made an order of the day for the next sitting.

10 TAXATION—PRESCRIBED PAYMENTS SYSTEM—MINISTERIAL STATEMENT: Mr Hurford (Acting Treasurer), by leave, made a ministerial statement announcing the intention of the Government to refine certain administrative aspects of the prescribed payments system of taxation.

- Mr Cadman and Mr Howard (Deputy Leader of the Opposition), by leave, also made statements with reference to the matter.
- Mr Hurford, by leave, made a further statement on the matter.
- 11 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—ORGANISED CRIME—NATIONAL CRIMES COMMISSION: Mr Speaker informed the House that Mr Hall had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The Government's unwillingness to confront the problem of organised crime, including its failure to establish a National Crimes Commission".

The proposed discussion having received the necessary support--

Mr Hall addressed the House.

Discussion ensued.

Discussion concluded.

- 13 NORTHERN TERRITORY GRANT (SPECIAL ASSISTANCE) BILL 1983: Mr Hurford (Acting Treasurer), pursuant to notice, presented a Bill for an Act to grant financial assistance to the Northern Territory.

Bill read a first time.

Mr Hurford moved—That the Bill be now read a second time.

Debate adjourned (Mr Braithwaite), and the resumption of the debate made an order of the day for the next sitting.

14 BOUNTY (AGRICULTURAL TRACTORS) AMENDMENT BILL 1983: Mr J. J. Brown (Minister Assisting the Minister for Industry and Commerce), pursuant to notice, presented a Bill for an Act to amend the Bounty (Agricultural Tractors) Act 1966. Bill read a first time.

Mr J. J. Brown moved—That the Bill be now read a second time.

Debate adjourned (Mr Braithwaite), and the resumption of the debate made an order of the day for the next sitting.

15 BOUNTY (TRACTOR CABS) BILL 1983: Mr J. J. Brown (Minister Assisting the Minister for Industry and Commerce), pursuant to notice, presented a Bill for an Act to provide for the payment of bounty on the production of certain tractor cabs.

Bill read a first time.

Mr J. J. Brown moved-That the Bill be now read a second time.

Debate adjourned (Mr Braithwaite), and the resumption of the debate made an order of the day for the next sitting.

16 BOUNTY (INJECTION-MOULDING EQUIPMENT) AMENDMENT BILL 1983: Mr J. J. Brown (Minister Assisting the Minister for Industry and Commerce), pursuant to notice, presented a Bill for an Act to amend the *Bounty (Injection-moulding* Equipment) Act 1979.

Bill read a first time.

Mr J. J. Brown moved—That the Bill be now read a second time.

Debate adjourned (Mr Braithwaite), and the resumption of the debate made an order of the day for the next sitting.

17 DAIRYING INDUSTRY RESEARCH AND PROMOTION LEVY AMENDMENT BILL 1983: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Kerin (Minister for Primary Industry), the Bill was read a third time.

18 DAIRY INDUSTRY STABILIZATION LEVY AMENDMENT BILL 1983: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

On the motion of Mr Kerin (Minister for Primary Industry), by leave, the following amendments were made together, after debate:

Clause 2, page 1, lines 9 and 10, omit "the day on which it receives the Royal Assent", substitute "a day to be fixed by Proclamation".

Clause 4, page 3, line 27, omit "50% or such higher", substitute "such".

Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr Johnson reported accordingly.

- On the motion of Mr Kerin, by leave, the House adopted the report, and, by leave, the Bill was read a third time.
- 19 DAIRY INDUSTRY LEGISLATION AMENDMENT BILL 1983: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

Mr McVeigh, by leave, moved the following amendments together:

Clause 6—

Page 4, at the beginning of proposed sub-section 24A (4) insert "Subject to sub-section 8,".

Page 4, at the end of proposed section 24A add the following sub-section:

- " '(8) The Minister, with respect to the Australian dairy industry's investment in overseas companies—
 - (a) shall not give a direction to the corporation under sub-section (4); and
 - (b) shall, in consultation with the Corporation, the Australian Dairy Industry Conference and the Australian Dairy Farmers Federation, examine all options available for the meeting of losses incurred by means of investments of this kind, with recourse to use of moneys held in export pools being considered only as a last resort.'.".

Debate continued.

Amendments negatived.

Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr Johnson reported accordingly.

On the motion of Mr Kerin (Minister for Primary Industry), the House adopted the report, and, by leave, the Bill was read a third time.

20 STATUTE LAW (MISCELLANEOUS PROVISIONS) BILL (NO. 2) 1983: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

- On the motion of Mr Bowen (Minister representing the Attorney-General), the Bill was read a third time.
- 21 SUSPENSION OF STANDING ORDER 48A: Mr Bowen (Leader of the House), by leave, moved—That standing order 48A, as amended by the sessional order of 24 August 1983, relating to the adjournment of the House, be suspended for this sitting. Question—put and passed.
- 22 PRIVATE INTERESTS OF MEMBERS OF PARLIAMENT—RESOLUTION AND REFERENCE TO STANDING ORDERS COMMITTEE: Mr Bowen (Leader of the House), pursuant to notice, moved—That this House—
 - (1) notes that Ministers have provided statements of their private interests, and those of their families of which they are aware, and that copies of those returns have been presented to the Parliament as a matter of public record;
 - (2) is of the opinion that all Members should provide similar statements of their private interests, including those of their families of which they are aware, covering the following matters:
 - (a) shareholdings in public and private companies (including holding companies) indicating the name of the company or companies;
 - (b) family and business trusts and nominee companies-
 - (i) in which a beneficial interest is held, indicating the name of the trust, the nature of its operation and beneficial interest; and
 - (ii) in which the person or immediate family is a trustee, indicating the name of the trust, the nature of its operation and the beneficiary of the trust;
 - (c) real estate, including the location (suburb or area only) and the purpose for which it is owned;
 - (d) directorships in private companies, indicating the name of the company, its activities and the total amounts of its assets and liabilities;
 - (e) partnerships, indicating the nature of the interest, the activities of the partnership and the total amounts of its assets and liabilities;
 - (f) liabilities (excluding short-term credit arrangements) indicating the nature of the liability and the creditor concerned;
 - (g) the nature of any bonds, debentures and like investments;
 - (h) saving or investment accounts, indicating their nature and the name of the bank or other institutions concerned;
 - (i) the nature of any other assets (including collections, but excluding household and personal effects) each valued at over \$5000;
 - (j) the nature of any other substantial sources of income;
 - (k) gifts valued at more than \$250 received from official sources, or at more than \$100 where received from other than official sources;
 - (l) any sponsored travel or hospitality received; and
 - (m) any other interests, such as membership of organisations, where a conflict of interest with a Member's public duties could foreseeably arise or be seen to arise;
 - (3) agrees that a public register of Members' statements of their private interests referred to in paragraph (2) should be established;
 - (4) agrees that Members should provide such statements on an annual basis and that amended statements should be provided if alterations in circumstances occur;
 - (5) agrees that notwithstanding the lodgement of statements by Members and their incorporation in a public register individual Members should declare any relevant interest if they participate in a debate in the House or vote in a division in the House, and

- (6) requests the Standing Orders Committee to consider and report upon-
 - (a) what changes to the standing orders may be required to give effect to the matters contained in paragraphs (2) to (5) of this resolution, and
 - (b) the desirability of adopting other provisions relating to Senators and Members contained in the report of the Committee of Inquiry into Public Duty and Private Interest (except constitutional matters, but including, in particular, a Code of Conduct).
- Paper: Mr Bowen, by leave, presented the following paper:
- Pecuniary interests—Variations to statements of Minister's presented to the Parliament on 22 September 1983.
- Mr Sinclair (Deputy Leader of the National Party of Australia) moved the following amendment: Omit paragraphs (2) to (6), substitute the following paragraph:
 - "(2) requests the Standing Orders Committee to consider and report upon—
 - (a) whether all Members should provide similar statements of their private interests, including those of their immediate families of which they are aware, covering the following matters:
 - (i) shareholdings in public and private companies (including holding companies) indicating the name of the company or companies;
 - (ii) family and business trusts and nominee companies-
 - (A) in which a beneficial interest is held, indicating the name of the trust, the nature of its operation and beneficial interest; and
 - (B) in which the person or immediate family is a trustee, indicating the name of the trust, the nature of its operation and the beneficiary of the trust;
 - (iii) real estate, indicating the location (suburb or area only) and the purpose for which it is owned;
 - (iv) directorships in private companies, indicating the name of the company, its activities and the total amounts of its assets and liabilities;
 - (v) partnerships, indicating the nature of the interest, the activities of the partnership and the total amounts of its assets and liabilities;
 - (vi) liabilities (excluding short-term credit arrangements) indicating the nature of the liability and the creditor concerned;
 - (vii) the nature of any bonds, debentures and like investments;
 - (viii) saving or investment accounts, indicating their nature and the name of the bank or other institutions concerned;
 - (ix) the nature of any other assets (including collections, but excluding household and personal effects) each valued at over \$5000;
 - (x) the nature of any other substantial sources of income;
 - (xi) gifts valued at more than \$250 received from official sources, or at more than \$100 where received from other than official sources;
 - (xii) any sponsored travel or substantial hospitality received, and
 - (xiii) any other interests, such as membership of organisations, where a conflict of interest with a Member's public duties could foreseeably arise or be seen to arise;
 - (b) whether a public register of Members' statements of their private interests referred to in sub-paragraph (a) should be established or whether there should be a private register held by the Speaker;
 - (c) whether the provision of material by a Member to the register should be on a compulsory or voluntary basis;
 - (d) whether Members should provide such statements on an annual basis and what amended statements should be provided if alterations in circumstances occur;
 - (e) whether, notwithstanding the lodgement of statements by Members and their incorporation in a register, individual Members should declare any relevant interest if they participate in a debate in the House or vote in a

division in the House and if so what might constitute a relevant interest and in what way it might be declared;

- (f) what changes to the standing orders may be required to give effect to the matters contained in sub-paragraphs (a) to (e) of this paragraph, and
- (g) the desirability of adopting other provisions relating to Senators and Members contained in the report of the Committee of Inquiry into Public Duty and Private Interest (except constitutional matters, but including, in particular, a Code of Conduct).".
