Missen, and moved—That this House expresses its deep regret at the death, on 30 March 1986, of Senator Alan Joseph Missen, a Senator for Victoria from 1974, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and the members of his family in their bereavement.
 - And Mr Howard (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

8 MESSAGE FROM THE SENATE—CUSTOMS ADMINISTRATION (TRANSITIONAL PROVISIONS AND CONSEQUENTIAL AMENDMENTS) BILL 1986: Message No. 232, dated 20 March 1986, from the Senate was reported transmitting for the concurrence of the House a Bill for "An Act to enact certain transitional provisions and make certain amendments in consequence of the enactment of the 'Customs Administration Act 1985', and for related purposes".

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—INTEREST RATES AND HOME LOANS: The House was informed that Mr Carlton had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The fear, worry and insecurity created in countless Australian families by the Government's high interest rate policies and its confused and inequitable actions on home loans".

The proposed discussion having received the necessary support—
