# TUESDAY, 20 MAY 1986

- 1 The House met, at 2 p.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 MINISTERIAL ARRANGEMENTS: Mr Bowen (Acting Prime Minister) informed the House of the following ministerial arrangements during the respective absences abroad of Mr Hawke (Prime Minister), Mr Hayden (Minister for Foreign Affairs), Mr Hurford (Minister for Immigration and Ethnic Affairs), Mr Cohen (Minister for Arts, Heritage and Environment) and Senator Evans (Minister for Resources and Energy):

He was acting as Prime Minister;

- Senator Button (Minister for Industry, Technology and Commerce) was acting as Minister for Foreign Affairs and would be represented in this House by Mr Beazley (Minister for Defence);
- Mr Holding (Minister for Aboriginal Affairs) was acting as Minister for Immigration and Ethnic Affairs and Mr J. J. Brown (Minister for Sport, Recreation and Tourism) was acting as Minister Assisting the Treasurer;
- Mr Scholes (Minister for Territories) was acting as Minister for Arts, Heritage and Environment, and
- Mr Jones (Minister for Science) was acting as Minister for Resources and Energy.
- 3 QUESTIONS: Questions without notice were asked.
- 4 TREASURER AND GOVERNMENT—MOTION OF CENSURE: Mr Howard (Leader of the Opposition), by leave, moved—That this House censures the Treasurer and the Government for—
  - (1) having deceived and misled the Australian public about the real state of the Australian economy for at least the past 12 months;
  - (2) the chronic loss of confidence and instability created by the public displays of disunity and point scoring between the Treasurer and the Prime Minister;
  - (3) the intemperate language of the Treasurer in explaining his latest diagnosis of the Australian economy, and
  - (4) the Treasurer's failure to inform fully the Australian people of the Government's current views of the economy and the policy response it proposes.

"(8A) In reviewing, under sub-section (8), principles applicable to a State, the Minister shall, after the relevant State Minister has consulted a body or bodies representative of local government in the State with respect to the proposed review, consult with the relevant State Minister."

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

The House resumed; Mr McLeay reported accordingly.

On the motion of Mr Uren, by leave, the House adopted the report.

Mr Uren, by leave, moved-That the Bill be now read a third time.

Debate ensued.
