"(4A) Where the Inspector-General proposes to set out in a report in relation to an inquiry conducted under this Act opinions that are, either expressly or impliedly, critical of a person, the Inspector-General shall, unless doing so would, in the opinion of the Inspector-General, prejudice security, the defence of Australia or Australia's relations with other countries, give the person a reasonable opportunity to appear before the Inspector-General and to make, either orally or in writing, submissions in relation to the matters that are the subject of the inquiry."

Page 10, line 26, after "sub-section (4)" insert "or (4A)".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole.

Proposed new clause-

Mr Spender moved—That the following new clause be added to the Bill:

Termination of Act

"36A (1) This Act, unless sooner repealed, shall cease to be in force at the expiration of the period of 3 years after the date of commencement of this Act.

(2) For the purposes of section 8 of the Acts Interpretation Act 1901, when this Act ceases to be in force by virtue of sub-section (1), it shall thereupon be deemed to have been repealed by an Act other than this Act.".

Clause 19, page 4, proposed sub-section 9 (2A), lines 24-27, omit all words after "agency" (first occurring) to the end of the proposed sub-section.

Clause 27, page 7, line 13, omit-

"Penalty: \$5,000 or imprisonment for 2 years",

substitute-

"Penalty: \$25,000 or imprisonment for 5 years".
