19 MESSAGE FROM THE SENATE—PARLIAMENTARY COMMISSION OF INQUIRY (REPEAL) BILL 1986: The following message from the Senate was reported:

Message No. 323

Madam Speaker,

The Senate returns to the House of Representatives the Bill for "An Act to repeal the 'Parliamentary Commission of Inquiry Act 1986', and for related purposes", and acquaints the House that the Senate has agreed to the Bill with the Amendments indicated by the annexed Schedule, in which Amendments the Senate requests the concurrence of the House of Representatives.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

No. 1—Page 2, clause 5, lines 3 to 11, leave out the clause.

No. 2—Page 2, sub-clause 7 (3), line 25, after "law", insert ", during the period of 30 years after the commencement".

- No. 3—Page 2, sub-clause 7 (4), lines 38 to 40, leave out the sub-clause, insert the following sub-clause:
 - "(4) Notwithstanding any other law, a person is not entitled to have access to, or to make use of—
 - (a) a class A document after the end of the period of 30 years after the commencement; or
 - (b) a class B document at any time,

except in accordance with the written authority of the Presiding Officers.".

- No. 4—Page 3, clause 8, lines 15 to 27, leave out the clause, insert the following clause:
 - "8. (1) A person who is, or has at any time been, a member of the Commission, a member of the staff of the Commission or counsel assisting the Commission shall not, directly or indirectly, disclose to any other person or make use of any document or information to which the first-mentioned person has had access by reason of being or having been such a member or counsel.

Penalty: \$5 000 or imprisonment for 6 months, or both.

- "(2) Sub-section (1) does not prevent or hinder—
- (a) the performance of any act otherwise authorised by this Act or the repealed Act as continued in effect by this Act; or
- (b) the participation of a person in any investigation undertaken by a person or organization referred to in section 7, or any proceedings, in which use is made of information or documents referred to in section 7.
- "(3) Sub-section (1) does not apply in relation to anything done in accordance with an authority given under sub-section 7 (4).".
- On the motion of Mr Bowen (Attorney-General), amendments Nos. 1 to 3 were agreed to, after debate.
- Mr Bowen moved—That Senate amendment No. 4 be disagreed to, but that, in place thereof, clause 8 be omitted and the following clause be substituted in the Bill:
 - "8. (1) A person shall not publish, or otherwise disclose to any other person, the whole or any part of a class A document that has been prepared by the Commission, the staff of the Commission, or counsel assisting the Commission.

Penalty:

- (a) where the defendant is a natural person—\$5,000 or imprisonment for 6 months, or both; or
 - (b) where the defendant is a corporation—\$100,000.
 - "(2) Sub-section (1) does not apply in relation to anything done—
 - (a) in accordance with an authority given under sub-section 7 (4); or
 - (b) for the purposes of any proceedings for an offence against sub-section (1).
- "(3) In this section, 'class A document' has the same meaning as in section 7.". Debate ensued.

Question—put and passed.

Resolutions to be reported.

The House resumed; Mr Ruddock reported accordingly.

On the motion of Mr Bowen, the House adopted the report.

20 ADJOURNMENT: Mr Bowen (Attorney-General) moved—That the House do now adjourn.
