- 1 The House met, at 2 p.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 PRIVILEGE—COMPLAINT OF BREACH: Mr Sinclair (Leader of the National Party of Australia) raised, as a matter of privilege, the content of an article in *The Daily Telegraph* of 1 September 1986 which referred to reported statements by the Minister for Immigration and Ethnic Affairs.

Mr Sinclair produced a copy of the article.

Madam Speaker stated that she would consider the matter and advise the House in due course.

- 3 LEADER OF THE NATIONAL PARTY OF AUSTRALIA (MR SINCLAIR)—STATEMENT BY MADAM SPEAKER: Madam Speaker informed the House that she had appraised the statement made by the Leader of the National Party of Australia on 22 August 1986 following her reference in the House to remarks reportedly made by him at a press conference on 21 August 1986 and reported in The Canberra Times.
 - Madam Speaker stated that she had accepted the apology on the assumption that the remarks of the Right Honourable Member had been inaccurately reported but having examined the transcript of his remarks at the press conference and comparing them to his statement to the House, she could only conclude that he had misled the House. This action, in her opinion, constituted a contempt of the House.

Mr Sinclair addressed himself to the matter.

- Mr McLeay moved-That this House-
 - (1) is of the opinion that—
 - (a) the comments made by the Leader of the National Party of Australia during a press conference on Thursday, 21 August 1986, and correctly reported in *The Canberra Times* the following day were highly critical of Madam Speaker and—
 - (i) constitute a breach of the privileges of this House, and
 - (ii) were deliberately calculated to attack the Speaker's right to discipline Members by calling into question her personal character, and
 - (b) the Leader of the National Party's statement to the House on Friday, 22 August, being clearly at odds with his original comments, misled the House, and thus constitutes a contempt of the House, and
 - (2) condemns the Leader of the National Party of Australia for his personal reflections upon the character and integrity of the Speaker of this House and her capacity to perform her duties as Speaker.

Debate ensued.

Mr Sinclair having withdrawn the remarks to which the attention of the House had been drawn, and having apologised to the Speaker—Motion withdrawn, by leave.

Bury, and moved—That this House expresses its deep regret at the death, on 7 September 1986, of the Honourable Leslie Harry Ernest Bury, CMG, a Member of this House for the Division of Wentworth from 1956 to 1974 and a former Minister of the Crown, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his family in their bereavement.
 - And Mr Howard (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

"(3) Nothing in this Act shall be taken to authorise expenditure (otherwise than for the expenses of borrowing) after 30 June 1987.".

20 APPROPRIATION BILL (NO. 1) 1986-87—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

What do we want from the Government—Paper prepared by Rescue Australia's Collapsed Economy Committee.

Mr Carlton moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the passage of this Bill, the House condemns the Government for—

(1) the failure of the Budget to tackle Australia's fundamental economic problems, namely—

(a) the record and rising level of overseas debt;

(b) excessively high levels of government spending and taxation;

(c) an inflation rate 4 times the average of our major trading partners;

(d) interest rates once again approaching 20%;

(e) a wages policy that does not take account of the capacity of individual enterprises to pay, and

(f) the pernicious effects of the anti-business, anti-investment taxes such as the capital gains tax and the fringe benefits tax, and

(2) the loss of Australia's AAA international credit rating following the failure of the Budget".
