9 AUSTRALIAN INDUSTRY DEVELOPMENT CORPORATION AMENDMENT BILL 1986: Mr Jones (Minister Assisting the Minister for Industry, Technology and Commerce), pursuant to notice, presented a Bill for an Act to amend the Australian Industry Development Corporation Act 1970, and for related purposes. Bill read a first time.

Mr Jones moved—That the Bill be now read a second time.

Paper: Mr Hurford presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Cadman), and the resumption of the debate made an order of the day for the next sitting.

10 COMMONWEALTH GUARANTEES (CHARGES) BILL 1986: Mr Hurford (Minister Assisting the Treasurer), pursuant to notice, presented a Bill for an Act to permit the imposition of charges for certain guarantees given by the Commonwealth.

Bill read a first time.

Mr Hurford moved—That the Bill be now read a second time.

Paper: Mr Hurford presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Cadman), and the resumption of the debate made an order of the day for the next sitting.
