- 2 LEAVE OF HOUSE FOR PRODUCTION OF DOCUMENTS TENDERED TO STANDING COMMITTEE ON ABORIGINAL AFFAIRS AND ATTENDANCE OF OFFICERS AT COURT PROCEEDINGS: Mr Young (Leader of the House), pursuant to notice, moved—That, in response to the petitions of Bernard Dominic Brassil and George Joseph Nutman presented to the House on 15 November 1985 and 14 October 1986, respectively, this House grants leave—
 - (1) to the petitioners to issue subpoenss for the production in court of documents tendered by (a) the Aboriginal Legal Service Ltd and (b) Mr G. F. Burke, during the House of Representatives Standing Committee on Aboriginal Affairs' inquiry into the effects of asbestos mining on the Baryulgil community, and
 - (2) to an appropriate officer or officers of the House to attend in court and produce the said documents and the official report of the committee, and to give evidence in relation to the conduct of the inquiry which led to the report, provided that such officer or officers shall not be required to attend at any time which would prevent the performance of their duties in the Parliament,

with the intention that the said documents be available for production in all proceedings to which they are relevant.

Clause 31, page 22, lines 30 and 31, omit paragraphs (c) and (d), substitute the following:

"and (c) an approval given under sub-section 9 (1)." []

Clause 33, page 23, line 23, omit "(d) the power to make determinations under section 24;".

Findings of Tribunal

- "23. Section 60 of the Principal Act is amended—
- (a) by omitting from sub-section (1) 'or as to the question to which the assessment relates'; and
- (b) by inserting after sub-section (1) the following sub-section:
 - '(1A) The Tribunal shall not make findings in relation to an assessment that would, under section 61, have the effect of superseding any information that is, under sub-section 37 (2), deemed to be part of the assessment unless those findings state that, in the opinion of the Tribunal, the information is incorrect, incorrectly represented or could not reasonably be relevant to the requirements of security.'."
- No. 2—Page 24, clause 39, proposed new section 92P, lines 5 to 9, leave out the proposed new section.

 - (e) in the case of a person referred to in paragraph (b) of this section—by the Council under paragraph 9 (1) (c) of the Principal Act as so amended; or

(f) in the case of a person referred to in paragraph (c) of this section—by the Attorney-General under sub-section 35 (3) of the Principal Act as so amended.".
