TUESDAY, 28 APRIL 1987

1 The House met, at 2 p.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.

2 **MEMBER FOR NORTH SYDNEY (MR SPENDER)—PRIVATE PAPER—STATEMENT BY MADAM SPEAKER:** Madam Speaker referred to a private paper distributed by Mr Spender since the House last met for the purpose of discussion by the Strategy Committee of the Coalition parties and subsequently leaked to the press. She said every Member must be able to communicate freely with his or her colleagues through private papers or private discussions and it would be ludicrous to ask an honourable Member to reject his or her own writings.

Madam Speaker stated that she had raised the matter only because the paper had invoked wide media speculation and that she rejected the criticism contained in the paper.

Debate resumed by Mr Fife who moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “whilst not opposing the passage of the Bill, this House—

- (1) expresses concern that the establishment of this statutory authority may not best address the housing needs of service men and women;
- (2) regrets the failure of the Government to allow adequately for private home ownership requirements of the Australian Defence Force, and
- (3) urges greater delegation of financial responsibility to base and area commanders for the acquisition, repair and maintenance of defence housing, with appropriate audit controls”.
