- 1 The House met, at 10 a.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 **CUSTOMS TARIFF AMENDMENT BILL 1987:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
 Debate resumed by Mr Moore who moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “whilst not opposing the Bill the House is of the opinion that the uniform general tariff rate of duty on power electronic goods under reference should be further reduced in the medium to long term”.  
 Debate continued.  
 Amendment negatived.  
 Question—That the Bill be now read a second time—put and passed—Bill read a second time.  
 Leave granted for third reading to be moved forthwith.  
 On the motion of Mr Jones (Minister representing the Minister for Industry, Technology and Commerce), the Bill was read a third time.
- 3 **EXCISE TARIFF AMENDMENT BILL 1987:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
 Question—put and passed—Bill read a second time.  
 Leave granted for third reading to be moved forthwith.  
 On the motion of Mr Jones (Minister representing the Minister for Industry, Technology and Commerce), the Bill was read a third time.

  - (3) it imposes on financial institutions heavy obligations for the retention of records concerning financial transactions, yet no statement from the Business Regulation Review Unit of the cost of such measures has been provided to the House"—
