9 MESSAGE FROM THE SENATE—ELECTORAL MATTERS—JOINT STANDING COMMITTEE: The following message from the Senate was reported:

Message No. 10

Madam Speaker,

The Senate, having considered Message No. 7 of the House of Representatives, has agreed to the following Resolution in connection therewith:

- (1) That the Senate concurs in the Resolution transmitted to the Senate by Message No. 7 of the House of Representatives relating to the appointment of a Joint Committee on Electoral Matters, subject to the following modifications:
  - (a) paragraph (2), leave out the paragraph, insert the following paragraph: "(2) That the committee consist of 10 members, 3 Members of the House of Representatives to be nominated by the Government Whip or Whips, 2 Members of the House of Representatives to be nominated by the Opposition Whip or Whips, 2 Senators to be nominated by the Leader of the Government in the Senate, 1 Senator to be nominated by the Leader of the Opposition in the Senate and 2 Senators to be nominated by any minority group or groups or independent Senator or independent Senators.":
  - (b) paragraph (5), leave out "who shall have a deliberative vote and, in the event of an equality of voting, the chairman have a casting vote":
  - (c) after paragraph (6), insert the following new paragraph: "(6A) In the event of an equality of voting, the chairman, or the deputy chairman when acting as chairman, shall have a casting vote."; and

(d) paragraph (7), leave out "3", insert "4".

(2) That the provisions of the Resolution, so far as they are inconsistent with the Standing Orders, have effect notwithstanding anything contained in the Standing Orders.

The Senate requests the concurrence of the House of Representatives in the Senate's modifications of the Resolution transmitted to the Senate by the House.

No. 4—Page 2, subclause 4 (3), line 39, leave out "or (2)".

No. 5—Page 3, subclause 5 (2), lines 7 to 11, leave out the subclause.

- No. 6—Page 4, subclauses 9(2) and (3), lines 9 to 21, leave out the subclauses, insert the following subclauses:
  - "(2) Subsection (1) does not affect the expenditure of money appropriated under the heading 'ADVANCE TO THE MINISTER FOR FINANCE' in a relevant appropriation Act for the current financial year.
  - "(3) Nothing in this Act shall be taken to authorise expenditure (otherwise than for the expenses of borrowing) after 30 June 1988.".
- On the motion of Mr Holding (Minister for Employment Services and Youth Affairs), the amendments were agreed to, after debate.
