### THURSDAY, 1 SEPTEMBER 1988

- 1 The House met, at 10 a.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr D. M. Cameron, Mr Dobie, Dr Hewson, Mr Jull, Mr Porter, Mr Prosser and Mr Ruddock, from 882, 55, 338, 198, 2, 35 and 392 petitioners, respectively, praying that the decision to place certain pharmaceutical drugs on the authority only listing be abandoned.
  - Mr Charles, Dr H. R. Edwards, Mr Griffiths and Mr Pratt, from 21, 480, 263 and 7 petitioners, respectively, praying that the House call a national day of prayer for Australia.
  - Mr Andrew, Mr Rocher and Mr Shack, from 20, 119 and 415 petitioners, respectively, praying that legislation be passed to make participation in Government statistical surveys voluntary and to protect the privacy of Australians.
  - Mr Prosser and Mr Rocher, from 25 and 84 petitioners, respectively, in similar terms.
  - Mr Beale and Mr Charles, from 87 and 93 petitioners, respectively, praying that a request be made to the Romanian Government to abandon plans to destroy 7000 villages.
  - Mr Dobie and Mr T. A. Fischer, from 16 and 966 petitioners, respectively, praying that the incidence of crime and violence broadcast on television be reduced.
  - Dr H. R. Edwards, from 43 electors of the Division of Barker, in similar terms.
  - Mr Halverson and Mr Jull, from 197 and 110 petitioners, respectively, praying that the decision to place certain drugs on the "Authorities Required" list be reversed.
  - Mr Hicks and Mr Pratt, from 13 and 596 petitioners, respectively, praying that entry into Australia by homosexuals under the family reunion program be forbidden.
  - Mr Shack, from 25 residents of Western Australia, in similar terms.
  - Mr Kent and Mr Scott, from 700 and 150 petitioners, respectively, praying that importation of cobalt 60 and other radioactive substances be banned and regulations permitting irradiation of food in Austalia be disallowed.
  - Mr D. M. Cameron, from 109 petitioners, praying that steps be taken to minimise noise levels and alter flight paths at the new Brisbane domestic airport.
  - Mr Charles, from 23 petitioners, praying that the national flag not be changed except by a referendum.
  - Mr Shack, from 29 petitioners, in similar terms.

- Dr Charlesworth, from 102 petitioners, praying that tobacco advertising and sponsorship be free from Government control and certain other action be taken in relation to tobacco.
- Dr Charlesworth, from 200 petitioners, praying that the Constitutional Alteration (Electors Initiative) Bill 1987 be referred to a parliamentary committee and certain other action be taken in relation to the Bill.
- Mr Connolly, from 348 petitioners, praying that items covering the treatment of sun damaged skin and warts by specialists be reinstated on the medical benefits schedule.
- Mr Connolly, from 90 petitioners, praying that those involved in the public release of confidential medical information be censured.
- Mr Cowan, from 39 petitioners, praying that all advertising of alcohol on radio and television be banned.
- Mr Cowan, from 35 petitioners, praying that the importation and possession of child pornography be made a criminal offence and certain other action be taken in relation to pornography in the ACT.
- Mr Cowan, from 162 petitioners, praying that the Australian way of life be preserved and national identity be protected.
- Ms Crawford, from 318 residents of Queensland, praying that the existing post office at Runcorn, Qld be retained.
- Mrs Darling, from 129 petitioners, praying that homosexuals not be allowed to migrate to Australia.
- Mr Downer, from 137 petitioners, praying that moves to amalgamate repatriation General Hospitals with the State hospital system or the Department of Veterans' Affairs with other Government departments be rejected.
- Mr T. A. Fischer, from 252 petitioners, praying that the hire and sale of R, X and the proposed Non-Violent Erotica rated videos be banned.
- Mr Halverson, from 238 petitioners, praying that the recent changes to the Pharmaceutical Benefits Scheme which placed certain drugs on a restricted listing be reversed.
- Mr Kerr, from 59 petitioners, praying that X rated video material and its R rated equivalent be refused classification for the purpose of Commonwealth laws.
- Mr Kerr, from 144 petitioners, praying that the French Government be urged to abandon plans to use the Kerguelan Islands as its proposed nuclear testing base.
- Mr Kerr, from 332 petitioners, praying that the importation of any radioactive substances or machinery for the purposes of food irradiation be banned, and certain other action be taken in relation to food irradiation.
- Mr Tickner, from 370 petitioners, in similar terms.
- Mr McArthur, from 12 electors of the Division of Corangamite, praying that the Government be urged to refrain from signing the Draft Convention on Mutual Assistance in Tax Matters.
- Mr McArthur, from 311 petitioners, praying that the sale of violent videos, books and toys of violence be banned.
- Mr Mildren, from 133 petitioners, praying that due consideration be given to increasing the amount of funds available to local government authorities for roadworks.
- Mr Mildren, from 610 electors of the Division of Ballarat, praying that the importance of roads to the economy be recognised, federal funds for roads be increased and certain other action be taken in relation to road funding.
- Mr Moore, from 14 petitioners, praying that the granting of fishing rights within Australian waters to the Soviet Union be prevented.
- Mr A. A. Morris, from 170 members of the Anglican Church of Australia, Parish of Lambton, NSW, and members of the Mothers' Union, praying

that legislation allowing the availability of Non-Violent Erotica films and videos be or posed.

Mr Prosser, from 1400 residents of the Division of Forrest, praying that local government be allocated more resources to address the problem of deteriorating road networks.

Mr Scott, from 343 petitioners, praying that Australia withdraw from the Asian Regional Co-operative Project on Food Irradiation and from the International Consultative Group on Food Irradiation and certain other action be taken in relation to food irradiation.

Mr Shack, from 38 petitioners, praying that patients paying the same Medicare insurance levy receive an equal Medicare rebate for services regardless of where they are provided.

Mr Sharp, from 130 petitioners, praying that legislation permitting Australiawide distribution of "Erotica" videos not be enacted.

Mr Sharp, from 357 electors of the Division of Gilmore, praying that the clearance throughout Australia of all X rated videos now entitled Erotica be rejected, whether containing violence or not.

Mr Simmons, from 54 representatives of volunteers, user organisations, families and supporters of the Community Volunteers Program, praying that consideration be given to the proposal of the Community Volunteer Program and Volunteer Centre to be funded as Volunteer Referral Agencies.

# 5 HUMAN RIGHTS AND REFERENDUM QUESTION: Mr Webster, pursuant to notice, moved—That this House—

- (1) declares that this nation enjoys basic human rights and freedoms unequalled anywhere in the world, and that these rights and freedoms are not under threat:
- (2) acknowledges the inherent dangers in inserting "rights" clauses in a written Constitution; and
- (3) expresses its concerns that the changes to the Constitution proposed by referendum question number 4 would allow Commonwealth governments to meddle with and deprive Australians of their basic rights and freedoms.

Debate ensued.

The time allotted for the debate having expired, the debate was interrupted, the resumption of the debate made an order of the day for the next sitting Thursday, and Mr Lavarch was granted leave to continue his speech when the debate is resumed.

# 6 LOCAL GOVERNMENT—CONSTITUTIONAL RECOGNITION: Mr Simmons, pursuant to notice, moved—That this House—

(1) notes that there are 3 tiers of Government in Australia;

- (2) recognises the contribution of dedicated men and women who are prepared to serve their local communities in public office; and
- (3) calls upon the Australian people to endorse strongly the Government's proposal for Constitutional recognition of local government.

Debate ensued.

The time allotted for the debate having expired, the debate was interrupted, the resumption of the debate made an order of the day for the next sitting Thursday, and Mr Free was granted leave to continue his speech when the debate is resumed.

7 SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) AMENDMENT BILL 1988: The order of the day having been read for the second reading—

- 13 SUSPENSION OF STANDING AND SESSIONAL ORDERS—MOTION OF CENSURE OF THE GOVERNMENT: Mr Spender moved—That so much of the standing and sessional orders be suspended as would prevent the honourable Member for North Sydney moving forthwith a motion of censure of the Government.

  Ouestion—put and passed, with the concurrence of an absolute majority.
- 14 MOTION OF CENSURE OF THE GOVERNMENT: Mr Spender moved—That this House censures the Government for the incalculable and lasting damage done to the conduct of foreign affairs by this Government consequent upon the revelation of the views held by its former Foreign Minister.
