# TUESDAY, 28 FEBRUARY 1989

- 1 The House met, at 2 p.m., pursuant to adjournment. Madam Speaker (the Honourable Joan Child) took the Chair, and read Prayers.
- 2 RESIGNATION OF MEMBER: Madam Speaker announced that, on 24 February 1989, she had received from the Honourable Ralph James Dunnet Hunt a letter resigning his seat as Member for the electoral division of Gwydir, in the State of New South Wales, and that consideration was being given to the date of the by-election.
- 3 DEATH OF MF: L. F. REES: Mr Hawke (Prime Minister) referred to the death of Mr L. F. Rees, and moved—That this House expresses its deep regret at the death, on 1 December 1988, of Lloyd Frederic Rees, AC, CMG, artist, places on record its appreciation of his long and meritorious service to Australian art and tenders its profound sympathy to his family in their bereavement.
  - And Mr Howard (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Ouestion—passed.

- 4 DEATH OF FORMER SENATOR (MR A. G. POKE): Madam Speaker informed the House of the death, on 4 January 1989, of Mr Albert George Poke, a Senator for the State of Tasmania from 1956 to 1974.
  - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 5 MINISTERIAL ARRANGEMENTS: Mr Hawke (Prime Minister) informed the House that, during the absence abroad of Mr Duffy (Minister for Trade Negotiations), Senator Evans (Minister for Foreign Affairs and Trade) would perform Mr Duffy's duties and would be represented in this House by Mr Beazley (Minister for Defence).
- 6 QUESTIONS: Questions without notice being asked—
  - Suspension of standing and sessional orders—Motion of censure of Prime Minister: Mr Howard (Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Leader of the Opposition noving forthwith a motion of censure of the Prime Minister.

Question—put and passed, with the concurrence of an absolute majority.

Prime Minister—Motion of censure: Mr Howard moved—That this House censures the Prime Minister for his persistent misleading of the Australian people about the true state of the economy, as exemplified by:

(1) his statement regarding taxation, interest rates, wages and prices during the Oxley by-election; and

(2) his claim made before the Western Australian election that interest rates would not rise before they fell.
