 - Mr Beddall, Mr Griffiths, Mrs Harvey, Mr Howard, Mr Johns, Mr Miles and Mr Moore, from 63, 19, 44, 20, 20, 8 and 16 petitioners, respectively, praying that the importation and availability of pornography in videos, films and television be banned and certain other action be taken in relation to pornography.
 - Mr Campbell, Mr McArthur, Mr O'Neil, Mr Pratt, Mr Reith and Mr Webster, from 81, 27, 297, 27, 21 and 33 petitioners, respectively, praying that the decision to place certain pharmaceutical drugs on the "Authority only" listing be abandoned.
 - Mr Katter, Mr Kent and Mr White, from 88, 36 and 1048 petitioners, respectively, praying that the aged pension be increased to 30 per cent of average veekly earnings and certain other action be taken in relation to pensions.
 - Mr Chynoweth and Mr Langmore, from 57 and 200 petitioners, respectively, praying that mining and mineral exploration in the Kakadu conservation zone be halted and certain other action be taken in relation to Kakadu National Park.
 - Ms McHugh and Mr J. L. Scott, from 882 and 47 petitioners, respectively, praying that Australia withdraw from the Asian Regional Co-operative Project on Food Irradiation and from the International Consultative Group on Food Irradiation and certain other action be taken in relation to food irradiation.
 - Mr Campbell, from 894 petitioners, praying that the decision to tax gold producers be reversed.
 - Mr Downer, from 299 petitioners, praying that Ranjeet and Parmjeet Heer be returned to Australia and exempted from conditions set down by immigration officials.
 - Dr H. R. Edwards, from 18 petitioners, praying that the excessive reliance on high interest rates as the major economic policy weapon cease.

Mr T. A. Fischer, from 96 petitioners, praying that CPI-based increases to fuel excise be halved and the proportion of this tax spent on roads increased by one half.

Mr T. A. Fischer, from 7 petitioners, praying that the administration of tax file number related legislation by the Australian Taxation Office be referred to the House of Representatives Standing Committee on Finance and Public Administration for investigation.

Mr Hawke, from 171 residents of Victoria, praying for the promotion of an immediate ceasefire in Lebanon and for United Nations assistance in bringing about a resolution of hostilities and withdrawal of all foreign troops.

Mr Kent, from 393 petitioners, praying that importation of cobalt 60 and other radioactive substances be banned and regulations permitting irradiation of food in Australia be disallowed.

Mr Langmore, from 236 petitioners, praying that woodchipping be phased out and certain other action be taken in relation to the forests of south eastern Australia.

Mr Lee, from 101 petitioners, praying that Social Security legislation be amended to correct an anomaly which exists in the assessment of income of World War II veterans who did not serve in a theatre of war.

Mr Pratt, from 20 petitioners, praying that legislation be amended to increase immediately the level of spending on maintenance and development of the national road system.

Mr Prosser, from 28 petitioners, praying for the immediate imposition of a moratorium on food irradiation and for certain other action in relation to the use of ionising radiation.

Mr Smith, from 5 petitioners, praying that the provision of an adequately funded pharmaceutical benefits scheme which provides a comprehensive range of modern therapeutic products be guaranteed.

Mr Snow, from 68 petitioners, in similar terms.

Mr Snowdon, from 16 petitioners, praying that the introduction of food irradiation into Australia be blocked and certain other action be taken in relation to the irradiation of food.

Dr Woods, from 746 petitioners, praying that the restructuring of the Pharmaceutical Benefits Scheme be reconsidered.

Dr Woods, from 202 petitioners, praying that a request be made to the Romanian Government to abandon plans to destroy 7000 villages.

- 4 WORLD POPULATION: Mr Hollis, pursuant to notice, moved—That this House:
 - (1) notes that the world population is now in excess of five billion people, of whom three billion reside in Asia;
 - (2) considers that the overriding problem facing the world is that of a rapidly increasing population which is making ever increasing demands on the world's natural resources, thereby threatening ever greater environmental damage: and
 - (3) considers that this population problem is the most serious aspect of the world's overall environmental problems.

- 5 HUMAN RIGHTS IN BRAZIL: Mr Ruddock, pursuant to notice, moved—That, while welcoming advances for the provision of human rights contained in Brazil's newly adopted constitution, this House:
 - (1) conveys to the President of Brazil its concerns about the killings of peasants, indigenous peoples, rural trade union leaders, lawyers and religious workers in the area; of rapid economic development;
 - (2) calls upon the Brazilian Government to take urgent measures to ensure that the rule of law is applied equally throughout Brazil and that good faith investigations be undertaken into those reported political killings; and
 - (3) urges the Brazilian Government it ensure that prompt and effective inquiries are made into allegations of arbitrary arrests and ill-treatment of peasants by local law enforcement agents.

 - (1) its prevarication over major national development projects where minority viewpoints have been allowed to prejudice a rational balance between valid environmental concerns and development proposals and delay Government decision;
 - (2) its failure to recognise land use as properly the responsibility of State and Northern Territory Governments;
 - (3) not providing an explicit role for the States in the Resource Assessment proposal;
 - (4) failing to ensure consultation with the States before the appointment of special Commissioners to the Resource Assessment Commission;
 - (5) using the Resource Assessment Commission concept to atone for public reaction against the Government's last minute intervention on the Wesley Vale Pulp Mill; and
 - (6) providing yet another layer between development applications and Government approval to the detriment of proposals designed to ameliorate Australia's chronic balance of payments problems through their contribution to Australian export revenue and in offsetting domestic imports"—

Debate resumed.
