- 1 The House met, at 2 p.m., pursuant to adjournment. Mr Speaker (the Honourable Leo McLeay) took the Chair, and read Prayers.
- 2 MINISTERIAL ARRANGEMENTS: Mr Hawke (Prime Minister) informed the House that, during the absence abroad of Mr Jones (Minister for Science, Customs and Small Business), Senator Button (Minister for Industry, Technology and Commerce) would perform Mr Jones' duties and would be represented in this House by Mr Duffy (Minister for Trade Negotiations).
- 3 QUESTIONS: Questions without notice were asked.
- 4 SUSPENSION OF STANDING AND SESSIONAL ORDERS-MOTION OF CENSURE OF PRIME MINISTER: Mr Peacock (Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Leader of the Opposition moving forthwith—That this House censures the Prime Minister for his arrogant disregard for the impact of his Government's mismanagement on Australian families and businesses struggling under record high interest rates and struggling to cope with the continuing fall-out from the pilots' dispute.

Question-put and passed, with the concurrence of an absolute majority.

5 PRIME MINISTER--MOTION OF CENSURE: Mr Peacock (Leader of the Opposition) moved—That this House censures the Prime Minister for his arrogant disregard for the impact of his Government's mismanagement on Australian families and businesses struggling under record high interest rates and struggling to cope with the continuing fall-out from the pilots' dispute.

Debate ensued.

Mr Keating (Treasurer) moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "this House expresses its concern at the total failure of the Opposition to produce a credible alternative economic strategy, as evidenced by the so-called Economic Action Plan, which would result in a relaxation of fiscal policy, a less effective wages policy, a tighter monetary policy, and no effective mechanism to advance microeconomic reforms, all of which would contribute to a rise in the level of interest rates, massively increase the level of unemployment and smash the economic fabric and structure of this country".

The House resumed; Mr R. F. Edwards reported accordingly.

On the motion of Mr P. F. Morris, the House adopted the report.

Mr P. F. Morris moved—That Mrs Child, Mr Jenkins and the mover be appointed a committee to draw up reasons for the House of Representatives disagreeing to the amendment of the Senate.

Question-put and passed.

Mr P. F. Morris, on behalf of the committee, brought up such reasons, which were circulated, and are as follows:

## Reasons of the House of Representatives for disagreeing to the amendment of the Senate

The Senate amendment is not acceptable because:

- the amendment would reduce the effectiveness of the 1989-90 Budget measure seeking to overcome the deferral of tax payments—that otherwise arises with monthly remittances of income tax instalment collections withheld by employers from the salary or wages of employees—by closer matching of remittances to collections;
- (2) the amendment would reduce the 1989-90 revenue gain from the measure by an estimated \$50 million;
- (3) the income tax instalment collections to be remitted twice-monthly by major employers, including the employers the subject of the amendment, do not belong to them, and there is no case for allowing any such employer to retain the money for a longer period;

- (4) the measure is the first step in a strategy aimed at moving large employers to a twice-monthly system of remittance of income tax instalments deductions, and small employers, comprising the majority of remitters, to a less frequent system than at present; and
- (5) Government assistance to public benevolent institutions, hospitals and universities is appropriately provided by means of outlays measures which are subject to review and compared with competing demands for Corr monwealth funds in the Budgetary process. It would subvert this process to provide part of this funding by means of allowing selected institutions to use their employees' tax deductions for an extended period.

On the motion of Mr P. F. Morris, the committee's reasons were adopted.
