Joint Sitting of members of the Senate and of the House of Representatives in the Senate Chamber, convened by the Governor-General pursuant to section 44 of the Commonwealth Electoral Act 1918, to choose a person to hold the place in the Senate in the representation of the Australian Capital Territory rendered vacant by the resignation of the Honourable Susan Maree Ryan

- 1 MEETING: It being eight p.m., the time appointed by the Governor-General for the commencement of the Joint Sitting pursuant to the Instrument of the Governor-General, and Harry Evans, Acting Clerk of the Senate, and Alan Robert Browning, Clerk of the House of Representatives, attending in their places according to their duty as Joint Clerks of the Joint Sitting—
  - And members of the Senate and of the House of Representatives having taken their seats—
  - The President of the Senate (Senator the Honourable Kerry Sibraa) and the Speaker of the House of Representatives (the Honourable Joan Child) were announced. The President took the Chair, pursuant to the rules adopted by the Senate and the House of Representatives for the Joint Sitting.
- 2 JOINT SITTING—STATEMENT BY CHAIRMAN: The Chairman stated that, pursuant to section 44 of the Commonwealth Electoral Act 1918, the Joint Sitting was being held to choose a person to hold the place in the Senate in the representation of the Australian Capital Territory rendered vacant by the resignation of the Honourable Susan Maree Ryan.

The Instrument convening the Joint Sitting was read by the Acting Clerk of the Senate, as follows:

# CONVENING OF JOINT SITTING OF MEMBERS OF THE SENATE AND THE HOUSE OF REPRESENTATIVES UNDER SECTION 44

I, SIR NINIAN MARTIN STEPHEN, Governor-General of the Commonwealth of Australia, having been notified by the President of the Senate in accordance with subsection 44 (5) of the Commonwealth Electoral Act 1918 that the place

of a senator for the Australian Capital Territory has become vacant before the expiration of her term of service, acting with the advice of the Federal Executive Council and pursuant to subsection 44 (1) of that Act hereby convene a joint sitting of the members of the Senate and the House of Representatives of the Parliament of the Commonwealth for the purpose of choosing a person to hold the place until the expiration of the term and appoint 16 February 1988 as the day for the members of the Senate and the House of Representatives to assemble for that purpose.

All members of the Senate and the House of Representatives are hereby required to give their attendance accordingly at Parliament House, Canberra, in the Australian Capital Territory, at 8 o'clock in the evening on 16 February 1988.

3 CHOICE OF SENATOR: The Chairman having called for proposals of candidates for the vacant place in the Senate—

Robert Francis McMullan was proposed by the Prime Minister (Mr Hawke), who announced that the candidate was willing to hold the vacant place if chosen and that the proposal was in accordance with subsection 44 (3) of the Commonwealth Electoral Act 1918.

The proposal was seconded by the Leader of the Government in the Senate (Senator Button).

The Leader of the Opposition (Mr Howard), the Leader of the National Party of Australia (Mr Sinclair), the Leader of the Opposition in the Senate (Senator Chaney), the Deputy Leader of the Opposition (Mr Peacock) and the Leader of the Australian Democrats (Senator Haines) spoke to the proposal.

There being only one person proposed, the Chairman put the Question—That Robert Francis McMullan be chosen to hold the place of the Senator for the Australian Capital Territory rendered vacant by the resignation of the Honourable Susan Maree Ryan.

Question put and passed.

The Chairman declared that Robert Francis McMullan had been chosen to hold the place of the Senator for the Australian Capital Territory rendered vacant by the resignation of the Honourable Susan Maree Ryan.

- 4 NOTIFICATON TO THE GOVERNOR-GENERAL: The Chairman stated that, in accordance with section 44 of the Commonwealth Electoral Act 1918, he would, in his capacity as President of the Senate, certify to His Excellency the Governor-General that Robert Francis McMullan had been duly chosen to hold the place in the Senate rendered vacant by the resignation of the Honourable Susan Maree Ryan.
- 5 CONCLUSION: The Joint Sitting concluded at 8.31 p.m.

#### **PROCLAMATION**

Commonwealth of Australia

By His Excellency the Governor-General of the Commonwealth of Australia

Bill Hayden Governor-General

WHEREAS section 5 of the Constitution of the Commonwealth of Australia provides that the Governor-General may, by Proclamation, dissolve the House of Representatives:

NOW THEREFORE I, WILLIAM GEORGE HAYDEN, Governor-General of the Commonwealth of Australia, by this Proclamation dissolve the House of Representatives at 4.00 o'clock in the afternoon on Monday 19 February 1990.

AND I discharge senators from attendance as from that time on that date and until the day appointed for holding the next session of the Parliament.
