Dr Theophanous produced copies of articles from the Melbourne Sunday Herald of 9 September 1990 and the Sydney Morning Herald of 10 September 1990 and gave the names of the publishers of those newspapers.

Mr Speaker stated that he would consider the matter and report to the House at a later hour this day.

13 MESSAGE FROM THE SENATE—END OF WAR LIST BILL 1989—REQUEST FOR RESUMPTION OF CONSIDERATION: The following message from the Senate was reported:

Message No. 48

Mr Speaker.

The Senate requests the House of Representatives to resume consideration of the bill entitled "A bill for an Act to establish an end of war list for Australian service personnel", which was transmitted to the House of Representatives for its concurrence on 2 November 1989 during the last session of the Parliament.

Statement by Mr Speaker: Mr Speaker made a statement on parliamentary procedure and the resumption of proceedings on lapsed bills.

Ordered—That the message be taken into consideration forthwith.

Mr Free (Parliamentary Secretary to the Prime Minister) moved—That the House of Representatives, having considered Senate Message No. 48 requesting the House to resume consideration of the Bill entitled "A Bill for an Act to establish an end of war list for Australian service personnel", resolves that a message be sent to the Senate stating that:

- the request is irregular in that it seeks to have the House resume consideration of a bill which lapsed at the dissolution of the House of Representatives and in respect of which the resumption of proceedings is effectively prevented by the standing orders of the House and accepted parliamentary practice;
- (2) the House does not intend to resume consideration of the bill as requested; and
- (3) if the Senate desires the House of Representatives to consider the bill, it is suggested that the Senate should introduce it again and transmit it to the House for concurrence in accordance with normal procedures. Debate ensued.

Question—put and passed.

14 APPROPRIATION BILL (NO. 1) 1990-91—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question— That the Bill be now read a second time— Debate resumed.

Privilege—Statement by Mr Speaker: Mr Speaker referred to the matter raised earlier this day by Dr Theophanous (see entry No. 2) regarding the alleged disclosure of the private deliberations of, and premature publication of the purported contents of a report of, the Joint Standing Committee on Migration Regulations.

Mr Speaker stated that he had concluded that a prima facie case had been made out such as would justify him according precedence to a motion on this matter. Mr Speaker stated that it might suit the convenience of the House if, rather than having a motion of referral moved at this stage, the matter be given further consideration by the Joint Standing Committee along the lines now followed in the British House of Commons whereby the committee concerned seeks to discover the source of the premature disclosure and assess whether it constitutes a substantial interference with its work or with the functions of the House. If the committee considers that there has been, or is likely to be, such interference, it should report to the House accordingly, and a report of this character could be referred to the Committee of Privileges.
