- 1 The House met, at 10 a.m., pursuant to adjournment. The Acting Speaker (Mr R. F. Edwards) took the Chair, and read Prayers.
 - 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Mack and Mr Sharp, from 20 and 19 petitioners, respectively, praying that immigrants be selected so that the existing ethnic structure of Australia is maintained.
 - Mr Andrew, from 7 petitioners, praying that the Therapeutic Goods Regulations be rejected and a public inquiry held into the registration of natural medicines.
 - Mr Beale, from 112 petitioners, praying that the United Nations Convention on the Rights of the Child not be ratified.
 - Mr O'Neil, from 347 petitioners, in similar terms.
 - Mr Beale, from 83 petitioners, praying for a twelve month moratorium followed by a referendum to enable the citizens of Australia to consider and decide whether the United Nations Convention on the Rights of the Child should be ratified.
 - Dr Catley, from 90 members of the Association of Ukrainians in South Australia, praying that the Ukrainian Republic's right to self-determination and national independence be supported and that the proposed Treaty between the USSR and the Ukrainian Republic be opposed.
 - Mr T. A. Fischer, from 76 electors of the Division of Farrer, praying that the sale and distribution of X-rated videos in the Australian Capital Territory and the Northern Territory be banned and that X-rated video material be proscribed.
 - Mr T. A. Fischer, from 39 petitioners, praying that legislative action be taken to protect the present Australian coat of arms and national flag and to impose certain penalties for the abuse of those symbols.
 - Mr Gayler, from 61 petitioners, praying that the Shark Bay region, WA, be declared a national park and nominated for World Heritage listing.
 - Dr Hewson, from 99 petitioners, praying that the position of the family as the basic unit of society be ensured and that certain other action be taken to maintain traditional family values.
 - Mr Hicks, from 440 residents of Broken Hill, NSW, praying that the Silver City Limited rail service be declared a community service obligation.
 - Mr McArthur, from 59 petitioners, praying that ratification of the United Nations Convention on the Rights of the Child be delayed pending community consideration and that reservations be submitted concerning the rights and responsibilities of parents.

Mr Mack, from 273 petitioners, praying that action be taken to phase out the consumption, production and export of chlorofluorocarbons and halons.

Mr Mack, from 17 petitioners, praying that action be taken to renegotiate or nullify the Treaty of Trianon (1920).

Mr Mack, from 13 petitioners, praying that the Otway Forests, Vic., be managed in the best interests of the Australian people and that the export woodchip licence granted to Midway Wood Products be rescinded.

Mr Mack, from 6 petitioners, praying that the production of ozone depleting substances be phased out and measures developed for their safe disposal.

Mr Nehl, from 2400 petitioners, praying for certain action to remove uncertainties and anomalies created for pensioners by the 1990-91 Budget.

Mr Nehl, from 179 petitioners, praying that funds be provided to enable the Pacific Highway to be made into a four-lane, divided dual carriageway from Hexham, NSW, to the Queensland border.

Mr Ruddock, from 208 petitioners, praying that certain action be taken to restore peace and order in Sri Lanka's Tamil homelands.

Clause 7, page 2, definition of '**provisional tax uplift factor**', lines 28 to 32, omit the definition, substitute the following definition:

" '**provisional tax uplift factor**', in relation to a year of income, means, until the Parliament otherwise provides, 10%;".

SCHEDULE OF THE REQUEST BY THE SENATE FOR AN AMENDMENT

Clause 3, page 1, lines 10 to 12, omit the clause, substitute the following clause:

"3. Section 7 of the Principal Act is repealed and the following section is substituted:

Levy of Tax

"7. The tax imposed by subsection 5(1) is levied, and shall be paid, for the financial year commencing on 1 July 1986 and for all subsequent financial years until the Parliament otherwise provides.'".
