- 1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Leo McLeay) took the Chair, and read Prayers.
- 2 **PETITIONS:** The Clerk announced that the following Members had each lodged petitions for presentation, viz.:  
Mrs Bailey, Mr Chaney and Mr Reid, from 41, 18 and 68 petitioners, respectively, praying that legislation preventing the right to advertise electoral material on radio and television be rejected.  
Mr Brereton, Dr H. R. Edwards and Mr Fitzgibbon, from 27, 60 and 353 petitioners, respectively, praying that funding of abortions through Medicare cease and that the right to life of the unborn be protected.  
Mr McGauran and Mr Webster, from 108 and 206 petitioners, respectively, in similar terms.  
Mr Burr and Mr Smith, from 38 and 153 petitioners, respectively, praying that the Abortion Funding Abolition Bill 1990 be passed and other action be taken to protect the right to life of the unborn.  
Mr Cadman and Mr Smith, from 199 and 7 petitioners, respectively, praying that the UN Convention on the Rights of the Child be amended to recognise the importance of the family unit and the rights and responsibilities of parents and that certain international treaties be debated in Parliament.  
Mr Moore and Mr Reith, from 3 and 191 petitioners, respectively, praying that legislation preventing the right to advertise political material on radio and television be rejected.  
Mr Cadman, from 9 petitioners, praying that any move to abolish political advertising be rejected and that public funding of political parties be abolished.  
Mr Hicks, from 324 electors of the Division of Riverina-Darling, praying that all aspects of the generic statement of firearms be rejected as being contrary to the States' rights of control and the private ownership of firearms.  
Mr McGauran, from 296 petitioners, praying that hormone replacement therapy be placed on the Pharmaceutical Benefits Scheme free list.  
Ms McHugh, from 60 petitioners, praying that any attempt to restrict access to abortion under Medicare be opposed.  
Mr Tuckey, from 43 petitioners, praying that no additional tax be levied on tobacco products as a source of funding sport and that the right of tobacco companies to sponsor sport and cultural events and the right of sporting and cultural groups to choose their own sponsor be supported.

- (2) applauds the efforts Amnesty International has made to the release of prisoners of conscience, ensuring fair trials for political prisoners and the ending of torture and executions world wide.

**13 AUSTRALIANS OF ITALIAN DESCENT:** Dr R. L. Woods, pursuant to notice, moved—That the House:

- (1) is of the opinion that grave injustices were done to many Australians of Italian descent who were interned during World War II;
- (2) acknowledges that many of these people were falsely accused of being fascists when in fact they left Italy because of their intense dislike of that ideology and the way in which it was being enforced by the then Italian Government;

- (3) whilst recognising the internment policy in the circumstances of the national emergency in which it was implemented, nevertheless regrets the suffering caused to certain innocent Australians of Italian descent who were interned;
- (4) recognises that many of those who were interned were loyal Australians who wished to see democracy triumph over nazism and fascism; and
- (5) investigate the possibility of having notations to the above effect appended to the internment records which are now part of the public record.

Debate ensued.

Page 14, lines 37–40, omit proposed subsection 314AA (2), substitute the following subsection:

“(2) Subsection (1) does not require particulars of a person or organisation referred to in paragraph (1)(a), (b) or (c) to be included in a return in the prescribed circumstances.”.
