- 2 ABSENCE OF SPEAKER: The Clerk having informed the House that the Speaker (the Honourable Leo McLeay) was absent on parliamentary business overseas, the Chairman of Committees (Mr R. F. Edwards) took the Chair as Acting Speaker, and read Prayers.
- 3 DEATH OF FORMER SENATOR (THE HONOURABLE SIR THOMAS DRAKE-BROCKMAN): Mr Keating (Prime Minister) referred to the death of the Honourable Sir Thomas Drake-Brockman, and moved—That the House expresses its deep regret at the death on Friday, 28 August 1992, of former Senator the Honourable Sir Thomas Charles Drake-Brockman, DFC, Senator for the State of Western Australia from 1958 to 1978, Minister for Air from 1969 to 1972, Minister for Aboriginal Affairs and Minister for Administrative Services in 1975, places on record its appreciation of his long and meritorious public service, and tenders its profound sympathy to his family in their bereavement.
 - And Dr Hewson (Leader of the Opposition) having seconded the motion, and Mr T. A. Fischer (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

- 11 SECURITY IN PARLIAMENTARY PRECINCTS—STATEMENT BY ACTING SPEAKER: The Acting Speaker made a statement relating to the wider review of the protective security of Parliament House which the Speaker had foreshadowed in his statement to the House on 18 August 1992. The Acting Speaker informed the House that the review had commenced and a report on the first stage of the assessment would be completed by 2 October 1992. The House was also informed that the next stage would consider changes to current security arrangements.
- 12 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—TRADE POLICY: The House was informed that both Mr Courtice and Mr Peacock had proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, the Acting Speaker had given priority to the matter proposed by Mr Courtice, namely, "The urgent need for the Government to refute the Opposition's recent statements on the United States' Export Enhancement Program and other trade policy matters which have diminished Australia's

international reputation and specifically put at risk Australia's multi-billion dollar export industries".

The proposed discussion having received the necessary support—

Mr Courtice addressed the House.

Discussion ensued.

Discussion concluded.

15 SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) AMENDMENT BILL 1992: The order of the day having been read for the resumption of the debate on the question-That the Bill be now read a second time-

Debate resumed.

Adjournment negatived: It being 10.30 p.m.—The question was proposed— That the House do now adjourn.

Mr Baldwin (Minister Assisting the Treasurer) requiring the question to be put forthwith without debate-

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Baldwin, the Bill was read a third time.

16 SWIMMING POOLS TAX REFUND BILL 1992: The order of the day having been read for the resumption of the debate on the question-That the Bill be now read a second time-

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

Mr Rocher, by leave, moved the following amendments together:

Page 2, line 3, omit ", or under an agreement,".
Page 2, lines 13 and 14, omit ", whether the liability arose as a result of a refund agreement or otherwise".

Page 2, lines 15 to 17, omit the definition of "refund agreement".

Amendments negatived.

Clauses agreed to.

Proposed new clause-

Mr Rocher moved—That the following new clause be inserted in the Bill: Swimming Pool and Spa Association of Australia—Australian Taxation Office

Agreement not affected by Act

"3A. Nothing in this Act applies to the agreement constituted by conversations and letters in November 1990 between representatives of the Swimming Pool and Spa Association of Australia Limited and the Australian Taxation Office relating to *in situ* pool tax, or to any payment that the Commonwealth is liable to make to any person pursuant to that agreement.".

Debate continued.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr Jenkins reported accordingly.

Ordered—That the House will, at the next sitting, again resolve itself into the said committee.

17 ADJOURNMENT: Mr Baldwin (Minister for Higher Education and Employment Services) moved—That the House do now adjourn.

Question—put and passed.
