1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

#### 2 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr J. N. Andrew, Dr Kemp, Mr Slipper, Mr Somlyay and Mr Wakelin, from 120, 363, 101, 2118 and 159 petitioners, respectively, praying that the increases in petrol excise proposed in the 1993-94 Budget be opposed.

Mr Hall, Ms Henzell and Mr Snowdon, from 357, 7 and 14 petitioners, respectively, praying that instruments affirming the United Nations Declaration on the Elimination of All Forms of Intolerance and of Discrimination Based on Religion or Belief and the United Nations Convention on the Rights of the Child be disallowed.

Mr J. N. Andrew and Ms Worth, from 189 and 248 petitioners, respectively, praying that the proposal to increase the level of wholesale sales tax on wine from 20 to 31 per cent be abandoned.

Mr Fischer and Mr A. A. Morris, from 808 and 66 petitioners, respectively, praying that no change be made to the design or colour of the Australian national flag and that it continue to represent a true manifestation of the nation's history.

Mr Lloyd and Mr Reid, from 20 and 57 petitioners, respectively, praying that the proposal to charge off-road users of diesel fuel a tax equal to one per cent of the diesel fuel rebate be abandoned.

Mr Beale, from 19 petitioners, praying that no change be made to the national flag without a full referendum.

Mr Brereton, from 16 petitioners, praying that funding of abortions through Medicare cease and certain other action be taken to protect the right to life of the unborn

Ms Deahm, from 612 residents of New South Wales, praying that the Australian judiciary be reformed and re-educated and that women be equally represented.

Mr Halverson, from 472 petitioners, praying that the proposal to increase the level of wholesale sales tax on wine from 20 to 31 per cent be rejected.

Mr Langmore, from 2052 petitioners, praying that logging in the Deua wilderness and other forest areas of high conservation value in New South Wales be stopped.

Mr Lloyd, from 89 petitioners, praying that Australia remain a democratic constitutional monarchy with the Queen as head of state, represented in Australia by a Governor-General.

Mr McArthur, from 152 petitioners, praying that the Taxation (Deficit Reduction) Bill 1993 be amended to ensure a healthy Australian wine industry.

Mr Mack, from 156 petitioners, praying that certain action be taken to urge the Government of the Socialist Republic of Vietnam to stop intervening in religious affairs, to release religious leaders and to cease oppressing religious organisations, especially the Unified Vietnamese Buddhist Church.

Mr Mack, from 30 petitioners, praying that the use of genetic engineering and cloning of human beings, animals, plant life, microbes and foods be prohibited.

Mr A. A. Morris, from 95 petitioners, praying that Commonwealth powers be used to override State legislation designed to extinguish native title.

Mr Nugent, from 4060 petitioners, praying that funding for breast cancer research be increased and that a national strategy to control breast cancer be developed.

Mr Sinclair, from 88 residents of rural New South Wales, praying that the Prices Surveillance Authority's findings in relation to price charging at Sydney Kingsford-Smith Airport be reviewed and that a fair and just system be introduced.

Mr Snowdon, from 371 petitioners, praying that Medicare continue to be a universal health insurance system and that eye tests be covered.

Mr Truss, from 30 petitioners, praying that the current national flag be preserved and no change be made to its design unless supported by referendum by the majority of Australians in the majority of States.

Mr Tuckey, from 15 petitioners, praying that the rights of State governments alone to define and issue land title be reaffirmed through a referendum.

Ms Worth, from 2 petitioners, praying that the proposal to increase the duty on leaded and unleaded petrol be abandoned.

#### 5 INDUSTRIAL AWARD SYSTEM

Mr Tanner, pursuant to notice, moved—That this House affirms that:

- (1) the award system of labour market regulation has ensured that the distribution of income through the wage system is more equitable than in most other countries:
- (2) the award system ensures that non-unionists and industrially weaker workers have access to reasonable employment conditions as a result of the work of unions and unionists;
- (3) the removal of award minimum protections would expose many Australian workers to exploitation and lower wages without generating greater employment opportunities; and
- (4) reform of Australia's industrial relations system should focus on improving the award system not destroying it.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting Thursday.

# 6 AUDIT (AUDITOR-GENERAL AN OFFICER OF THE PARLIAMENT) AMENDMENT BILL 1993

Mr Connolly, pursuant to notice, presented a Bill for an Act to amend the Audit Act 1901 to make the Auditor-General an Officer of the Parliament.

Mr Connolly made a statement in relation to the Bill.

# 7 BREAST CANCER RESEARCH

The order of the day having been read for the resumption of the debate on the motion of Mr Evans—That this House:

- (1) deplores the fact that six Australian women per day die from breast cancer and notes the possibility of contracting breast cancer is as high as one chance in sixteen for Australian women;
- (2) recognises the fact that breast cancer has the potential to affect every Australian family;
- (3) recognises that there are inadequate research funds available to help combat breast cancer;
- (4) notes the extent of research funding expenditure on other medical conditions with significantly lower mortality rates such as the HIV virus;
- (5) calls on the federal Government to provide more funds for breast cancer research; and
- (6) recommends that the Government introduces tax incentives for donations to breast cancer research in the order of 150 per cent to encourage community support to help eliminate this disease and to increase the availability of research funds—

Debate resumed.
