1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

2 PETITIONS

The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Cadman, Mr Evans, Mr Miles and Mr B. C. Scott, from 2391, 1379, 162 and 139 petitioners, respectively, praying that the increases in petrol excise proposed in the 1993-94 Budget be opposed.

Mr Forrest, Mr Reid and Mr Ronaldson, from 878, 110 and 87 petitioners, respectively, praying that the proposal to charge off-road users of diesel fuel a tax equal to one per cent of the diesel fuel rebate be abandoned.

Mr Evans and Mr Hawker, from 52 and 22 petitioners, respectively, praying that measures to treat unrealised capital gains and losses on listed securities as income under the *Social Security Act 1991* and the *Veterans' Entitlements Act 1986* be abandoned.

Mr Hawker and Mr Lieberman, from 98 and 20 petitioners, respectively, praying that no action be taken to change the national flag unless approved by the people of Australia in a national poll.

Mr Cameron, from 1249 residents of Western Australia, praying that action be taken to stop the practice in China of extracting bile from caged bears for medical purposes.

Mr Downer, from 33 petitioners, praying that the increases in wholesale sales tax, petrol excise, tax on wine and tax on lump sums received for unused leave proposed in the 1993-94 Budget be rejected.

Mr Hawker, from 578 petitioners, praying that the increase in excise on leaded fuel be rejected and that certain action be taken to reduce the cost of manufacturing cars in Australia.

Mr Hawker, from 27 petitioners, praying that Medicare continue to be a universal health insurance system and that all eye examinations by optometrists be covered.

Mr Miles, from 69 petitioners, praying that the guidelines for homeless rate recipients be reviewed and greater commitment shown to programs which prevent family breakdown.

Mr Moore, from 605 petitioners, praying that planned expenditure on government buildings in Canberra and on a proposed new flag be opposed and the funds be applied to the betterment of this country.

Mr Ronaldson, from 40 petitioners, praying that certain action be taken to tighten restrictions against violence in the media.

Mr B. C. Scott, from 23 residents of Queensland, praying that any proposal to change the Australian flag be rejected.

NEWSPAPER AND TELEVISION REPORTS ON PROCEEDINGS OF JOINT COMMITTEE OF PUBLIC ACCOUNTS—REFERENCE TO COMMITTEE OF PRIVILEGES

MATTER RAISED BY MRS SULLIVAN

The Speaker referred to the matter of privilege raised yesterday by Mr L. J. Scott concerning articles published in the *Australian* of 21 October 1993 and the *Financial Review* of 21 and 25 October 1993 and a news report on the WIN television evening news of 25 October 1993 which appeared to reveal details of a forthcoming report of the Joint Committee of Public Accounts and its private deliberations. The Speaker stated that the unauthorised disclosure or publication of the contents of a draft report or of the private deliberations of a committee could be regarded as a contempt. He noted that the committee had considered the matter and was of the view that the publication of the material had caused substantial interference with its work. The Speaker stated that he was prepared to allow precedence to a motion in respect of the matter.

Mr L. J. Scott then moved—That the matter of articles in the Australian of 21 October 1993, the Australian Financial Review of 21 and 25 October 1993 and comments by Mr L. Oakes on the WIN evening news of 25 October 1993 which appeared to reveal a knowledge of the contents of a draft report and/or deliberations of the Joint Committee of Public Accounts be referred to the Committee of Privileges.

Question—put and passed—Mr Mack dissenting.

The Speaker also referred to the matter raised yesterday by Mrs Sullivan concerning an article in the *Sydney Morning Herald* of 27 October 1993 concerning a forthcoming report of the Standing Committee on Procedure.

The Speaker stated that, in accordance with the Speaker's statement of 7 May 1992, the Procedure Committee should now consider this matter and the effect of the publication of the article and should take steps to ascertain the source of any disclosure and report to the House accordingly.
