1 The House met, at 10 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

2 CRIMES (SEARCH WARRANTS AND POWERS OF ARREST) AMENDMENT BILL
1993

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Williams, viz.*—That all words after “That” be omitted with a view to substituting the following words: “whilst not declining to give the Bill a second reading, the Bill be referred to the Standing Committee on Legal and Constitutional Affairs for review”—

Debate resumed.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

Mr Kerr (Minister for Justice), by leave, moved the following amendments together:

Clause 4—

Page 3, after proposed subsection 3D(1) insert the following subsection:

“(1A) To avoid any doubt, it is declared that even though another law of the Commonwealth provides power to do one or more of the things referred to in subsection (1), a similar power conferred by this Part may be used despite the existence of the power under the other law.”.

Page 8, lines 5 to 17, omit proposed section 3G.

Page 30, after proposed section 3ZP insert the following section:

Announcement before entry

“‘3ZPA.(1) The executing officer or a constable assisting must, before any person enters premises under a warrant or to arrest a person:

- (a) announce that he or she is authorised to enter the premises; and
- (b) give any person at the premises an opportunity to allow entry to the premises.

‘(2) The executing officer or a constable assisting is not required to comply with subsection (1) if he or she believes on reasonable grounds that immediate entry to the premises is required to ensure:

- (a) the safety of a person (including the executing officer and the constable assisting); or
- (b) that the effective execution of the warrant or the arrest is not frustrated.”.

Page 32, line 24, omit “3ZH”, substitute “3ZI”.

Mr Kerr presented a supplementary explanatory memorandum to the Bill.

Amendments agreed to.

Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr Jenkins reported accordingly.

On the motion of Mr Kerr, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

3 PRIVILEGE—COMPLAINT OF BREACH

Mr Truss raised, as a matter of privilege, articles published in the *Australian* and the *Canberra Times* of 2 February 1994 which appeared to reveal details of a submission from Mrs Kelly (Minister for the Environment, Sport and Territories) to the Standing Committee on Environment, Recreation and the Arts. Mr Truss stated that publication of the submission had not been authorised and he would be raising the matter with the committee when it next met.

The Speaker stated that he would await the results of the committee’s deliberations on the matter.
