(b) an officer of the Department; and

(c) a person appointed on the nomination of the Maritime Union of Australia; and

(d) a person appointed on the nomination of stevedoring employers.’”.

Clause 10—

Mr Charles moved the following amendment: Omit the clause, substitute the following clause:

Functions of Committee

“10. Section 6 of the Principal Act is amended by omitting paragraphs (c), (ca), (d) and (e) and substituting the following paragraph:

‘(c) to make recommendations to the Minister as to when a levy should cease to apply.’”.

Clause 20—

Mr Brereton (Minister for Industrial Relations) moved the following amendment: Page 5, at the end of proposed section 26A add the following subsection:

“(2)If the Committee is satisfied that an employer of stevedoring employees is keeping the prescribed records in relation to those employees, the Committee is not required to include the names of those employees on the register.’.”.
