5 ANZAC DAY

Mr Holding, pursuant to notice, moved—That the House:

- (1) notes that the Anzacs who landed at Gallipoli on 25 April 1915 were instrumental in forging a new identity for Australia and further notes that although the landing was a lifetime ago the deeds of those Anzacs still speak a message of selfless service and sacrifice that will last forever;
- (2) recognises that Anzac Day is a day to remember those who left their homes with a strong desire to return but did not, as well as those who did return but carried with them for the remainder of their lives the scars of their experiences;
- (3) recognises that Anzac Day is a day to contemplate the spirit that moves men and women to serve, to suffer discomforts, dangers and fears and to risk their lives in defence of their country and in the pursuit of peace, justice and freedom:
- (4) salutes on Anzac Day the spirit of the Anzacs and in paying tribute to them calls on Australians to dedicate themselves to striving for their country as the Anzacs did and to upholding the finest qualities of courage, commitment, endurance and mateship; and
- (5) is of the view that the Australian Government should declare Anzac Day as Australia's National Day of Commemoration and that it be held on 25 April in each year and on no other day.

Debate ensued.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting Monday.

7 NEW DELHI STATEMENT ON TIBETAN FREEDOM

Mr Jenkins, for Mr Cleeland, pursuant to notice, moved—That:

- (1) this Parliament acknowledges and accepts as a resolution of this House the statement known as the New Delhi Statement on Tibetan Freedom; and
- (2) a copy of this resolution be forwarded to His Holiness the Dalai Lama and the Tibetan government in exile, presiding officers of the two Houses of the Indian Parliament, all Parliaments whose members are participating in the New Delhi Statement on Tibetan Freedom and the Chairman of the Chinese National People's Congress.

Paper: Mr Jenkins, by leave, presented the following paper:

Tibetan freedom—New Delhi statement by World Parliamentarians Convention on Tibet, 20 March 1994.

Mr Howe also informed the House that, during the respective absences of Mr Crean (Minister for Employment, Education and Training) and Mr Brereton (Minister for Industrial Relations and Minister for Transport), Mr Free (Minister for Schools, Vocational Education and Training) would answer questions on behalf of Mr Crean and Mr Johns (Assistant Minister for Industrial Relations) would answer questions relating to industrial relations and Mr Lee (Minister for Communications and the Arts and Minister for Tourism) would answer questions relating to transport on behalf of Mr Brereton.

10 DEATH OF FORMER MEMBER (THE HONOURABLE SIR DAVID FAIRBAIRN)

Mr Howe (Acting Prime Minister) referred to the death of the Honourable Sir David Fairbairn, KBE, DFC, and moved—That the House expresses its deep regret at the death on 1 June 1994, of the Honourable Sir David Eric Fairbairn, a Member of the House of Representatives from 1949 to 1975, Minister for Air from 1962 to 1964, Minister for National Development from 1964 to 1969, Minister for Education and Science 1971 and Minister for Defence from 1971 to 1972 and places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his family in their bereavement.

And Mr Downer (Leader of the Opposition) having seconded the motion, and Mr Fischer (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

11 D-DAY LANDINGS-50TH ANNIVERSARY

The Speaker referred to the 50th anniversary of the D-Day landings on the Normandy coast of France-

As a mark of respect to the great gallantry and courage displayed by the young men who took part 50 years ago in the landings and in particular to the 2600 Australian servicemen involved, all Members present stood, in silence.

Ms Crawford and Mr Humphreys, from 72 and 27 petitioners, respectively, praying that women remain eligible for the age pension from the age of 60.

Mr J. N. Andrew, from 8 petitioners, praying that no action be taken to change the national flag unless approved by the people of Australia in a national poll.

Mr Beale, from 80 petitioners, praying for certain changes to the Family Law Act and the Child Support Scheme.

Mr Beale, from 16 petitioners, praying that no change be made to the national flag without a full referendum.

Mr Braithwaite, from 3042 residents of the Mackay/Pioneer area, Qld, praying that funds be provided to enable SBS Television to telecast in the Mackay/Pioneer region.

Mr Braithwaite, from 40 petitioners, praying that the national flag not be changed, replaced or diminished without being voted upon and approved in a national referendum.

Mr Dobie, from 16 petitioners, praying that legislative action be taken to implement the Earth Repair Charter.

Mr Fischer, from 79 petitioners, praying that legislation be implemented to enable alternative forms of medical treatment to be recognised under Medicare.

Mr Kerr, from 37 electors of the Division of Denison, praying that legislation governing, and the administration of, the Child Support Agency be reviewed.

Mr Sharp, from 101 petitioners, praying that the existing Australian flag be retained and Australians be given the opportunity to express that wish through a referendum.

Mr Truss, from 58 electors of the Division of Wide Bay, praying that transmission of the Special Broadcasting Service into the Wide Bay region, Qld, be provided as soon as possible.
