1 The House met, at 12.30 p.m., pursuant to adjournment. The Acting Speaker (Mr Jenkins) took the Chair, and read Prayers.

2 MATTERS REFERRED TO MAIN COMMITTEE

Mr McLeay (Chief Government Whip), having amended, by leave, notice No. 1, government business, moved—That the following orders of the day be referred to the Main Committee for debate:

3 COMMUNICATIONS AND THE ARTS LEGISLATION AMENDMENT BILL 1994

The order of the day having been read for the second reading—Mr Elliott (Parliamentary Secretary to the Minister for Communications and the Arts) moved—That the Bill be now read a second time.

Debate ensued.

Question—put and passed—Bill read a second time.

Consideration in detail

Bill, by leave, taken as a whole.

Dr Kemp, by leave, moved the following amendments together:

Schedule-

Page 3, omit item 1, substitute the following item:

"1. Subsection 70(1):

Omit 'The Corporation shall not, without the approval of the Minister', substitute 'The Corporation must, not later than 14 days before it enters into a contract referred to in paragraph (a) or (b) as the case may be, notify the Minister that it proposes to'.".

Page 16, omit item 122, substitute the following item:

"122. Subsection 67(1):

Omit 'The SBS must not, without the approval of the Minister', substitute 'The SBS must, not later than 14 days before it enters into a contract referred to in this subsection, notify the Minister that it proposes to'.".

Debate continued.

Amendments negatived.

Bill agreed to.

Consideration in detail concluded.

On the motion of Mr Elliott, by leave, the Bill was read a third time.

4 VETERANS' AFFAIRS LEGISLATION AMENDMENT BILL (NO. 3) 1994

The order of the day having been read for the second reading—Mr Sciacca (Minister for Veterans' Affairs) moved—That the Bill be now read a second time. Debate ensued.

12 CORPORATIONS LAW (SECURITIES AND FUTURES) AMENDMENT BILL 1994

The order of the day having been read for the second reading—Mr Duncan (Parliamentary Secretary to the Attorney-General) moved—That the Bill be now read a second time.

Mr Ruddock moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House deplores the manner in which the Government and the Attorney-General have handled the Bill to date, and in particular condemns:

- (1) the inappropriate provisions contained in the Bill for facilitating the ASX's desire to trade share ratios;
- (2) the initial attempt to pass the amendments without consultation;
- (3) the Government's clear inability to come to grips with the regulation of derivatives in Australia; and
- (4) the Attorney-General's administrative bungling of the proposed legislation". Debate continued.

Debate adjourned (Mr Abbott), and the resumption of the debate made an order of the day for the next sitting.

13 TAXATION LAWS AMENDMENT (DROUGHT RELIEF MEASURES) BILL 1995

Mr Snowdon (Parliamentary Secretary to the Minister for the Environment, Sport and Territories) presented a Bill for an Act to amend the law relating to taxation. Bill read a first time.

Paper: Mr Snowdon presented an explanatory memorandum to the Bill.

Ordered—That the second reading be made an order of the day for the next sitting.

14 ADJOURNMENT

Mr Snowdon (Parliamentary Secretary to the Minister for the Environment, Sport and Territories) moved—That the House do now adjourn.
