Bill, as amended, agreed to.

On the motion of Mr Beazley (Minister for Finance), by leave, the Bill was read a third time.

**2 DEFENCE LEGISLATION AMENDMENT BILL 1995**

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

*Messages from the Governor-General:* The following messages from His Excellency the Governor-General were announced:

No. 270, dated 6 April 1995, recommending an appropriation for the purposes of the Bill; and

No. 271, dated 29 May 1995, recommending an appropriation for the purpose of amendments to the Bill.

*Consideration in detail*

Bill, by leave, taken as a whole.

On the motion of Mr Punch (Minister for Defence Science and Personnel), by leave, the following amendments were made together, after debate:

*Amendment—*

Clause 3, page 2, line 8, omit “Schedules 1 to 5”, substitute “Schedules 1, 2, 3, 4, 5 and 5A”.

*New schedule—*

After Schedule 5 insert the following Schedule:

**“SCHEDULE 5A**

Section 3

**AMENDMENT OF THE SAFETY, REHABILITATION AND  
COMPENSATION ACT 1988**

**1. Subsection 6A(2):**

Omit the subsection, substitute:

‘(2) If, at any time, whether before, on, or after, 1 December 1988:

- (a) an employee to whom this section applies received or receives medical treatment paid for by the Commonwealth; and
- (b) as an unintended consequence of that treatment the person suffered or suffers an injury;

the injury to the employee is taken to have arisen out of, or in the course of, the person’s employment, whether or not the person has remained an employee to whom this section applies.’ ”.

*Amendment—*

Title, page 1, after “**relating to defence**” insert “**and the Safety, Rehabilitation and Compensation Act 1988**”.

Bill, as amended, agreed to.

Consideration in detail concluded.

Ordered—That the Bill be reported to the House with amendments and with an amended title.

### 3 PRIMARY INDUSTRIES AND ENERGY LEGISLATION AMENDMENT BILL (NO. 2) 1995

The order of the day having been read for the second reading—Mr Bevis (Parliamentary Secretary to the Minister for Defence) moved—That the Bill be now read a second time.

Debate ensued.

Question—put and passed—Bill read a second time.

*Message from the Governor-General:* Message No. 272, dated 13 March 1995, from His Excellency the Governor-General was announced recommending an appropriation for the purposes of the Bill.

Leave granted for the motion for the Bill to be reported to be moved forthwith.

On the motion of Mr Punch (Minister for Defence Science and Personnel), Bill to be reported to the House without amendment.
