1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Stephen Martin) took the Chair, and read Prayers.

2 PUBLIC ORDER (PROTECTION OF PERSONS AND PROPERTY) AMENDMENT BILL 1995

The order of the day having been read for the second reading—Mr Tickner (Minister for Aboriginal and Torres Strait Islander Affairs) moved—That the Bill be now read a second time.

Debate ensued.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Tickner, the Bill was read a third time.

3 HUMAN SERVICES AND HEALTH LEGISLATION AMENDMENT BILL (NO. 2) 1995

The order of the day having been read for the second reading—Dr Theophanous (Parliamentary Secretary to the Minister for Human Services and Health) moved—That the Bill be now read a second time.

Dr Wooldridge moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Labor government for the ad hoc and piecemeal measures contained in this Bill, particularly the harsh changes to the Pharmaceutical Benefits Scheme general safety net, which will strike at Australians with chronic illnesses, Australians on low incomes with young families and retired Australians on fixed incomes".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 297, dated 2 August 1995, from His Excellency the Governor-General was announced recommending an appropriation for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Dr Theophanous, the Bill was read a third time.

4 STATES GRANTS (GENERAL PURPOSES) AMENDMENT BILL 1995

The order of the day having been read for the second reading—Mr Elliott (Parliamentary Secretary to the Treasurer) moved—That the Bill be now read a second time.

Mrs Bishop moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for:

- (1) its continuing mismanagement of Commonwealth-State relations; and
- (2) its threat to recoup from any State funds paid to that State as a result of the Parliament of that State repealing laws which prescribe compulsory student unionism at universities".

Debate continued.

It being 3 p.m., the debate was interrupted in accordance with standing order 101A, and the resumption of the debate made an order of the day for a later hour this day.

5 DEATH OF FORMER MEMBER (MR R. H. WHITTORN)

The Speaker informed the House of the death, on Thursday, 10 August 1995, of Mr Raymond Harold Whittorn, CBE, a Member of this House for the Division of Balaclava from 1960 to 1974.

The proposed discussion having received the necessary support—

Mrs Bishop addressed the House.

Discussion ensued.

Discussion concluded.
