1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Bob Halverson) took the Chair, and read Prayers.

2 DEATH OF FORMER MEMBER (HON, R. McN. HOLTEN)

Mr Howard (Prime Minister) referred to the death of the Honourable R. McN. Holten, and moved—That the House expresses its deep regret at the death on Saturday, 12 October 1996, of the Honourable Rendle McNeilage (Mac) Holten, CMG, a Member of this House for the Division of Indi from 1958 to 1977, Minister for Repatriation from 1969 to 1972 and Minister Assisting the Minister for Trade and Industry from 1971 to 1972, places on record its appreciation of his long and meritorious public service, and tenders its profound sympathy to his family in their bereavement.

And Mr Beazley (Leader of the Opposition) having seconded the motion, and Mr Fischer (Leader of the National Party of Australia) and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

3 NATIVE TITLE AMENDMENT BILL 1996—DRAFT AMENDMENTS—REFERENCE TO COMMITTEE

Mr Williams (Attorney-General and Minister for Justice), pursuant to notice, moved—

(1) That:

(a) the amendments to the Native Title Amendment Bill 1996 which are contained in the exposure draft presented to the House this day be referred to the Parliamentary Joint Committee on Native Title and the Aboriginal and Torres Strait Islander Land Fund for consideration and an advisory report to the House in conjunction with the Committee's consideration and reporting on the matter referred to the Committee on 27 June 1996;

- (b) the time for the advisory report by the Committee to the House be extended from 1 November 1996 to 18 November 1996; and
- (c) the terms of this resolution, so far as they are inconsistent with the standing and sessional orders, have effect notwithstanding anything contained in the standing and sessional orders.
- (2) That a message be sent to the Senate acquainting it of this reference to the Committee.

6 SUSPENSION OF STANDING AND SESSIONAL ORDERS—MOTION OF CENSURE OF THE PRIME MINISTER

Mr Beazley (Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Leader of the Opposition moving forthwith—That this House censures the Prime Minister:

- (1) for his failure in leadership in not ensuring that the standards he set for his government are met which require that his ministers be honest in their public dealings and that they not intentionally mislead the Parliament or the public;
- (2) for not demanding that a number of his ministers including the Minister for Foreign Affairs, the Minister for Employment, Education, Training and Youth Affairs, the Minister for Finance, the Minister for Industry, Science and Tourism, the Minister for Small Business and Consumer Affairs and the Minister for Trade fully meet those standards;
- (3) for his failure to ensure adherence to his guidelines which require the avoidance of a conflict or an apparent conflict between interests and duties including by the Minister for Industry, Science and Tourism; and
- (4) for the confusion and incompetence pervading his government which has meant that clear attention to the nation's needs for job growth and job security have been neglected; and

This House calls on the Prime Minister to show leadership, stop the double standards and dismiss the Deputy Prime Minister and Minister for Trade and his Minister for Industry, Science and Tourism.

Question—put and passed, with the concurrence of an absolute majority.

7 PRIME MINISTER—MOTION OF CENSURE

Mr Beazley (Leader of the Opposition) moved—That this House censures the Prime Minister:

- (1) for his failure in leadership in not ensuring that the standards he set for his government are met which require that his ministers be honest in their public dealings and that they not intentionally mislead the Parliament or the public;
- (2) for not demanding that a number of his ministers including the Minister for Foreign Affairs, the Minister for Employment, Education, Training and Youth Affairs, the Minister for Finance, the Minister for Industry, Science and Tourism, the Minister for Small Business and Consumer Affairs and the Minister for Trade fully meet those standards;
- (3) for his failure to ensure adherence to his guidelines which require the avoidance of a conflict or an apparent conflict between interests and duties including by the Minister for Industry, Science and Tourism; and
- (4) for the confusion and incompetence pervading his government which has meant that clear attention to the nation's needs for job growth and job security have been neglected; and

This House calls on the Prime Minister to show leadership, stop the double standards and dismiss the Deputy Prime Minister and Minister for Trade and his Minister for Industry, Science and Tourism.

Debate ensued.

Mr Howard (Prime Minister) moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "this House censures the Leader of the Opposition for the abuse of parliamentary process in pursuing groundless allegations against some Government Ministers when he himself has stated publicly that there is no suggestion of any impropriety by those Ministers and when he should have spent his time pursuing the proper interests and concerns of the Australian people".

Debate continued.
