Paper: Mrs Moylan (Minister for Family Services) presented a correction to the explanatory memorandum to the Bill.

Debate resumed by Dr Lawrence who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House:

(1) deplores the Government for abolishing operational subsidies for community-based long day care centres which will have the effect of increasing the costs and reducing the quality of child care for parents using these centres; and

(2) condemns the Government for breaking its election promise not to means test the Childcare Cash Rebate".

- (1A) A CFM body or a related body must make a payment to the legal personal representative of an employee if:
 - (a) the employee was an employee of the CFM body immediately before the body's sale day; and
 - (b) at that time, the employee's period of service for the purposes of the Long Service Leave Act was less than 10 years; and
 - (c) from and after the body's sale day, the employee continued to be employed by the CFM body or a related body; and
 - (d) on or after the body's sale day, the employee died and immediately before his or her death:
 - (i) the employee was an employee of the CFM body or a related body; and
 - (ii) the employee's combined service period was at least one year; and

(iii) the employee did not have any dependants.

Page 21 (line 28), after "(1)", insert "or (1A)".

Paper: Mr Fahey presented a supplementary explanatory memorandum to the Bill.

Mr S. F. Smith moved—That further proceedings on the Bill be conducted in the House.
