Mr Hawker was granted leave to continue his speech when the debate is resumed.

In accordance with standing order 102B, the debate was adjourned, and the resumption of the debate made an order of the day for the next sitting.

4 EXCISE TARIFF AMENDMENT (RURAL AND REGIONAL INFRASTRUCTURE) BILL 2001

Mr Katter, pursuant to notice, presented a Bill for an Act to amend the *Excise Tariff Act 1921*, and for related purposes.

Mr Katter made a statement in relation to the Bill.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting, in accordance with sessional order 104A.

5 POSTPONEMENT OF PRIVATE MEMBERS' BUSINESS NOTICE

The Clerk informed the House that pursuant to standing order 138 he had received a letter from Dr Theophanous fixing the next sitting as the day for presenting the Australian Bill of Rights Bill 2001.

6 PROPOSED APPROPRIATIONS AND STAFFING STANDING COMMITTEE

Mr Price, pursuant to notice, moved-

- (1) That a Standing Committee on Appropriations and Staffing be appointed to inquire into:
 - (a) proposals for the annual estimates and the additional estimates for the House of Representatives;
 - (b) proposals to vary the staff structure of the House of Representatives, and staffing and recruitment policies; and
 - (c) such other matters as are referred to it by the House;
- (2) That the committee shall:
 - (a) in relation to estimates—
 - (i) determine the amounts for inclusion in the parliamentary appropriation bills for the annual and the additional appropriations; and
 - (ii) report to the House upon its determinations prior to the consideration by the House of the relevant parliamentary appropriation bill; and
 - (b) in relation to staffing—
 - (i) make recommendations to the Speaker; and
 - (ii) report to the House on its determinations prior to the consideration by the House of the relevant parliamentary appropriation bill;
- (3) That the committee consist of the Speaker and 11 other members, 6 members to be nominated by the Chief Government Whip or Whips and 5 members to be nominated by the Chief Opposition Whip or Whips or any independent Member;
- (4) That the committee elect a Government member as its chair;
- (5) That the committee elect a deputy chairman who shall act as chair of the committee at any time when the chair is not present at a meeting of the

committee, and at any time when the chair and deputy chair are not present at a meeting of the committee the members present shall elect another member to act as chairman at that meeting;

- (6) That the committee have power to appoint subcommittees consisting of 3 or more of its members and to refer to any subcommittee any matter which the committee is empowered to examine;
- (7) That the committee appoint the chair of each subcommittee who shall have a casting vote only, and at any time when the chair of a subcommittee is not present at a meeting of the subcommittee the members of the subcommittee present shall elect another member of that subcommittee to act as chair at that meeting;
- (8) That the quorum of a subcommittee be a majority of the members of that subcommittee;
- (9) That members of the committee who are not members of a subcommittee may participate in the public proceedings of that subcommittee but shall not vote, move any motion or be counted for the purpose of a quorum;
- (10) That the committee or any subcommittee have power to send for persons, papers and records;
- (11) That the committee or any subcommittee have power to move from place to place;
- (12) That a subcommittee have power to adjourn from time to time and to sit during any sittings or adjournment of the House;
- (13) That the committee have leave to report from time to time; and
- (14) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.

Debate ensued.

At 1.45 p.m., the debate was interrupted in accordance with standing order 106A, Mr Charles was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for a later hour this day.

18 MIGRATION LEGISLATION AMENDMENT (INTEGRITY OF REGIONAL MIGRATION SCHEMES) BILL 2000

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Ruddock (Minister for Immigration and Multicultural Affairs), the Bill was read a third time.

19 TAXATION LAWS AMENDMENT (EXCISE ARRANGEMENTS) BILL 2000

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Crean (Deputy Leader of the Opposition), viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House condemns the Government for:

- (1) failing to listen to the community concerning the GST impact on excise levels;
- (2) opposing Labor's private member's bill giving a fuel excise cut to motorists yet allowing a Government backbencher to introduce his own private member's bill that would tear up the Intergovernmental Agreement signed with the States;
- (3) belatedly reducing only a portion of its GST fuel excise windfall merely because it is in a state of panic because of the upcoming Ryan by-election; and
- (4) its poor administration of the excise regime"—

Debate resumed.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration), the Bill was read a third time.

20 CRIMES AMENDMENT (FORENSIC PROCEDURES) BILL 2001

The order of the day having been read for the second reading—Mr Williams (Attorney-General) moved—That the Bill be now read a second time.
