### 15 MIGRATION AMENDMENT (EXCISION FROM MIGRATION ZONE) BILL 2001

Mr Ruddock (Minister for Immigration and Multicultural Affairs), pursuant to notice, presented a Bill for an Act to excise certain Australian territory from the migration zone under the *Migration Act 1958* for purposes related to unauthorised arrivals, and for related purposes.

Bill read a first time.

Mr Ruddock moved—That the Bill be now read a second time.

### 16 MIGRATION AMENDMENT (EXCISION FROM MIGRATION ZONE) (CONSEQUENTIAL PROVISIONS) BILL 2001

Mr Ruddock (Minister for Immigration and Multicultural Affairs), pursuant to notice, presented a Bill for an Act to make consequential provision for dealing with unauthorised arrivals in places excised from the migration zone under the *Migration Act 1958* for purposes related to unauthorised arrivals, and for related purposes.

# 17 BORDER PROTECTION (VALIDATION AND ENFORCEMENT POWERS) BILL 2001

Mr Ruddock (Minister for Immigration and Multicultural Affairs), pursuant to notice, presented a Bill for an Act to validate the actions of the Commonwealth and others in relation to the MV *Tampa* and other vessels, and to provide increased powers to protect Australia's borders, and for related purposes.

# 18 MESSAGE FROM THE SENATE—INTERNATIONAL MARITIME CONVENTIONS LEGISLATION AMENDMENT BILL 2001

Message No. 706, 30 August 2001, from the Senate was reported returning the International Maritime Conventions Legislation Amendment Bill 2001 with amendments.

## **19 BANKRUPTCY LEGISLATION AMENDMENT BILL 2001**

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr McClelland, viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House:

(1) condemns the government for introducing a tax system that has caused a significant increase in the number of bankruptcies;

- (2) condemns the government for failing to prevent the excesses of some sections of corporate Australia but scapegoating those ordinary citizens and unincorporated small businesses who are unable to pay their debts by virtue of the GST;
- (3) condemns the government for failing to act to stop tax avoidance by virtue of the improper use of the bankruptcy laws; and
- (4) calls on the government to act to stamp out illegal tax avoidance in all its forms"—

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Consideration in detail

Bill, by leave, taken as a whole.

Mr McClelland moved Opposition amendment (1).

Debate continued.

Amendment negatived.

Mr McClelland moved Opposition amendment (2).

Debate continued.

Amendment negatived.

## Paper

Mr Williams (Attorney-General) presented a supplementary explanatory memorandum to the Bill.

On the motion of Mr Williams, by leave, Government amendments (1) to (10) were made together, after debate.

Bill, as amended, agreed to.

Consideration in detail concluded.

On the motion of Mr Williams, by leave, the Bill was read a third time.

# 20 BANKRUPTCY (ESTATE CHARGES) AMENDMENT BILL 2001

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Williams (Attorney-General), the Bill was read a third time.

## 21 SUPERANNUATION LEGISLATION AMENDMENT (INDEXATION) BILL 2001

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr K. J. Thomson who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the bill a second reading, the House:

- (1) condemns the Government for its slow and disinterested handling of superannuation;
- (2) condemns the Government for its failure to satisfactorily deal with public service superannuation and to include the Defence Force Retirement Benefits (DFRB) scheme, the Defence Force Retirement and Death Benefits (DFRDB) scheme and the Military Superannuation and Benefits Scheme (MSBS) in the same benefits extended by this Bill to the Commonwealth Superannuation Scheme (CSS) and Public Sector Superannuation (PSS) scheme pensions;
- (3) condemns the Government for the delay in allowing twice yearly indexation of Commonwealth superannuation pensions; and
- (4) calls on the Government to examine in full the other recommendations of the Senate Select Committee on Superannuation and Financial Services, which in April 2001 released its report entitled *A Reasonable and Secure Retirement* ?".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.
