2 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Crean (Deputy Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Deputy Leader of the Opposition moving—That order of the day No. 42, Government business, be called on and debated forthwith in view of:

- (1) soaring petrol prices, especially in regional Australia, largely caused by the increase in tax on every litre of petrol due to the GST;
- (2) the failure of the Government to honour its promise to cut the petrol excise by an equivalent amount to the GST, leaving at least 1.5 cents more excise per litre;
- (3) the further indexation in petrol tax on 1 August which was driven by GST price increases in housing and insurance and on pre-emptive price increases before the GST commenced;
- (4) the cascading effect of the GST which is imposed on the excise indexation increase, meaning that the GST is a tax on a tax thereby further lifting petrol prices; and
- (5) the Government deliberately misleading the Australian public on the effect of the GST on petrol taxation, and that it is planning to increase the level of petrol tax by around a further 2 cents in February 2001 due to the indexation of petrol excise due to the direct inflation effect of the GST.
