VOTES AND PROCEEDINGS

OF THE

HOUSE OF REPRESENTATIVES.

WEDNESDAY, 10TH AUGUST, 1910.

1. The House met pursuant to adjournment.—Mr. Speaker took the Chair and read Prayers.
2. LAND TAX ASSESSMENT BILL.—Mr. Fisher moved, pursuant to notice, That he have leave to bring in a Bill for an Act relating to the Imposition, Assessment, and Collection of a Land Tax upon Unimproved Values.
Question—put and passed.
Mr. Fisher then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Ordered—That the second reading be made an Order of the Day for to-morrow.
3. CONCILIATION AND ARBITRATION BILL (1910).—The Order of the Day having been read for the third reading—
Mr. Kelly moved, That the Bill be now recommitted to a Committee of the whole House for the consideration of the following new clause :—
“A. Provision shall be made for the periodical audit of the books and affairs of organizations registered under this Act by a qualified accountant, who shall report to the members of organizations and to the Minister administering the Act on the various directions of the expenditure of industrial organizations.”
Question—That the Bill be now recommitted to a Committee of the whole House for the consideration of the proposed new clause—put.

Debate continued.

Question—That the word “now” proposed to be omitted stand part of the question—put and passed.

Question—That the Bill be now read a third time—put and passed.—Bill read a third time.

4. BANK NOTES TAX BILL.—The Order of the Day having been read for the second reading—Mr. Fisher moved, That the Bill be now read a second time.
Mr. Cook moved, That the debate be now adjourned.
Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.

5. SUGAR BOUNTY BILL (1910) (No. 2).—The Order of the Day having been read for the second reading—Mr. Tudor moved, That the Bill be now read a second time.
Mr. McWilliams addressing the House and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.
Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for to-morrow.

6. MESSAGE FROM THE SENATE.—SUPPLY BILL (No. 2) 1910-11.—Mr. Speaker announced the receipt of the following Message from the Senate:—
