# THURSDAY, 13TH OCTOBER, 1910.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. POSTAGE STAMPS OF EACH STATE EFFECTIVE THROUGHOUT COMMONWEALTH .-- Mr. Thomas, by leave, made the following statement to the House-

Instructions have been issued to-day to all Deputy Postmasters-General that, from and including to-day, postage stamps now issued in the various States are to be valid for the prepayment of postage at all Post Offices in the Commonwealth, so that from this date letters can be posted in any State prepaid by the stamps of any other State, and State boundaries therefore no longer exist so far as postage stamps are concerned.

This does not affect the rates of postage which must of necessity be continued pending legislation.

As a slight memento of the occasion every Member of the Federal Parliament will have a complete set of Australian Stamps presented to him.

- 3. EXPATRIATION REGULATION BILL.-The Order of the Day having been read for the second reading-Mr. Fowler moved, That the Bill be now read a second time.
  - Debate ensued.

Motion, by leave, withdrawn.

Ordered-That the Bill be withdrawn.

4. IMMIGRATION RESTRICTION [DEPORTATION OF CRIMINALS] BILL.—The Order of the Day having been read for the second reading-Mr. Fowler moved, That the Bill be now read a second time. Debate ensued.

Mr. Batchelor moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for Thursday next.

- 5. POSTFONEMENT OF BUSINESS.—Ordered, That the remaining General Business be postponed until Thursday next.
- 6. SUPPLY ["GRIEVANCE DAY"].—Pursuant to the provisions of Standing Order No. 241, the Order of the Day having been read for going into the Committee of Supply-Question-That Mr. Speaker do now leave the Chair-put and negatived. Resolved-That the House will, to-morrow, resolve itself into the said Committee.
