VOTES AND PROCEEDINGS

OF THE

HOUSE OF REPRESENTATIVES.

TUESDAY, 18TH OCTOBER, 1910.

1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. PAPER.—The following Paper was laid upon the Table by the Clerk :—
Post Offices, Illawarra—Officers Employed, Hours Worked, &c.—Return to an Order of the House, dated 11th October, 1910.
3. SEAT OF GOVERNMENT (ADMINISTRATION) BILL.—Mr. O'Malley moved, pursuant to notice, That he have leave to bring in a Bill for an Act to provide for the Provisional Government of the Territory for the Seat of Government of the Commonwealth.
Question—put and passed.
Mr. O'Malley then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Ordered—That the second reading be made an Order of the Day for to-morrow.
4. CONSTITUTION ALTERATION (LEGISLATIVE POWERS) BILL.—The Order of the Day having been read for the second reading—Mr. Hughes moved, That the Bill be now read a second time.
Mr. Deakin moved, That the debate be now adjourned.
Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.
5. CONSTITUTION ALTERATION (MONOPOLIES) BILL.—The Order of the Day having been read for the second reading—Mr. Hughes moved, That the Bill be now read a second time.
Mr. Deakin moved, That the debate be now adjourned.
Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.
6. NORTHERN TERRITORY ACCEPTANCE BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 5 further considered.

Debate resumed on the amendment moved by Mr. Higgs, viz. :—

At end of clause add—“with this proviso, that notwithstanding anything to the contrary expressed or implied, the Commonwealth may construct the transcontinental railway along such route within the Territory as may be deemed expedient”.

Amendment, by leave, withdrawn.

Clause further debated.

Mr. Batchelor moved, That the Chairman do report progress and ask leave to sit again.
