- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PAPER.—Mr. O'Malley presented, pursuant to Statute—

Lands Acquisition Act—Land acquired under, at Jervis Bay, New South Wales—For Commonwealth purposes.

3. Arbitration (Public Service) Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.
