3. Address-in-Reply to His Excellency the Governor-General's Speech.—The Order of the Day having been read for the resumption of the debate on the question—That the following Address-in-Reply to the Speech of His Excellency the Governor-General be agreed to by this House:—

MAY IT PLEASE YOUR EXCELLENCY-

We, the House of Representatives of the Parliament of the Commonwealth of Australia, in Parliament assembled, beg to express our loyalty to our Most Gracious Sovereign, and to thank Your Evollary for the Speech which you have been pleased to address to Parliament.

Your Excellency for the Speech which you have been pleased to address to Parliament—

And on the Amendment moved by Mr. Deakin, viz.:—That the following words be added to the Address:—"and to inform Your Excellency that the Government merits the censure of the House and the country for its failure to realize its national and constitutional obligations, for flagrant neglect of its duty to secure industrial peace and good order and to uphold the law within the Commonwealth; for its maladministration of public affairs and public departments, for its grossly partisan actions and appointments and its reckless irresponsibility in the financial affairs of the Commonwealth"——

Debate resumed.

Sir John Quick addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.

Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for to-morrow.
